The meeting was called to order by the Presiding Commissioner at 1:33pm.

Subject: Approval of Hospital Revenue Bonds

Commissioner Stamper welcomed Tom Schneider, Legal Counsel for the Boone Hospital Board of Trustees and Barbara Weaver, chair of the Boone Hospital Board of Trustees.

Commissioner Vogt stated that the Boone Hospital Board of Trustees has been investigating ways financing options for the proposed capital improvements to Boone Hospital. She stated that County government held a meeting earlier this morning with the Auditor, Treasurer, County Clerk, and the County Commission to discuss a previous meeting (two weeks ago) concerning various kinds of bond financing with the Boone Hospital Board of Trustees.

Commissioner Vogt stated that the County Commission invited the Boone Hospital Trustees to today's County Commission meeting in order to make public the County's intention in regards to the issuance of bonds for the capital improvements.

Barbara Weaver stated that if the hospital lease were for a longer period of time or if the hospital had some other arrangement with the County, then the Boone Hospital Board of Trustees would consider a different funding option. She stated that the BHC Trustees met with the Bond Council and also with their financial advisor. She stated that the BHC Trustees now feel fairly comfortable in moving forward with this kind of funding. She stated that she is requesting, on behalf of the BHC Trustees, that the County Commission allow the BHC Trustees to move forward with the issuance of \$11-12 million in variable rate, demand bonds for the Boone Hospital Center capital improvements and renovation.

Commissioner Vogt stated that the County would first need a revised timeline and some other information before moving forward.

Barbara Weaver stated that there was a copy of some of that information available for the County Commission today. She stated that in order to proceed with the CON hearing on April 3rd, the BHC Trustees had to prepare a lot of that information in advance. She stated that the actual bonds could not be issued until after that hearing. She stated that the BHC Trustees would appear before the County Commission with a formal request for the issuance of bonds following that hearing.

Tom Schneider stated that County Treasurer Kay Murray contacted the Bond Council about the form of Lease Addendum. Tom Schneider stated that he has possession of the 1992 Addendum which shows that BJC (Barnes, Jewish, Christian, Inc.) is to pay the debt service.

Commissioner Vogt stated that the Addendum states that BJC will pay off the debt for the period of time that they are leasing the facility (Boone Hospital Center).

Commissioner Vogt moved to agree to support the Hospital Board of Trustees procedures on identifying and creating an avenue to fund the capital improvement projects for Boone Hospital Center in an amount not to exceed \$12 million.

Commissioner Miller seconded the motion.

Discussion: Barbara Weaver stated that the BHC Trustees have not worked out the exact figure for the project as of yet. She stated that the County Commission could leave that part of the Commission Order out if they wished.

Commissioner Stamper stated that this figure would be close to the actual figure for the bond financing. He stated that he wanted to express to the media and the public the level of funding that is being proposed.

Commissioner Miller stated that she thought that the other documents, including the Resolution for Bond Council, would come forward before the County Commission expressed its intention on this matter.

Commissioner Vogt stated that the remainder of the documents, including the Resolution for the Bond Council are already in progress.

Commissioner Stamper stated that the County recognizes that there are other needs (for the project/funding) that might come forward as this process moves along. He stated that the County would address those needs as they come forward, however this motion would serve as a starting point to address the immediate needs of the BHC Trustees.

Commissioner Reports

Commissioner Stamper

Commissioner Stamper reported that he attended a meeting in Jefferson City with the new Central Region (a consolidation of SDA-5 and SDA-9). He stated that all 19 Presiding Commissioners were in attendance. He reported that the plan, articles, and by-laws (on behalf of the elected officials) were approved. He noted that he was elected vice-chair of the organization. He stated that the chair of the organization is the Presiding Commissioner from Washington County.
