**Subject: Purchasing Department** 

### A. Second Reading of Surplus Property for Disposal

Marlene Ridgeway, Purchasing Department Buyer, present on behalf of this item.

Marlene Ridgeway stated there has been no interest shown in any of the items listed on the September 11, 2001 memo from the Purchasing Department. She stated the Purchasing Department is requesting disposal of the listed items.

Commissioner Miller asked Mrs. Ridgeway if the Sheriff's Department had checked on the availability of any of the filing cabinets for the Mental Health contractor to use. Mrs. Ridgeway stated that she contacted Sheriff Boehm after the meeting on Tuesday and there has been no response from him.

Commissioner Miller moved adoption:

#### **Anti-Terrorism Resolution**

**Whereas**, on September 11, 2001, the United States was suddenly and brutally attacked by foreign terrorists, and;

Whereas, these terrorists hijacked and destroyed four civilian aircraft, crashing two of them into the towers of the World Trade Center in New York City, and a third into the Pentagon outside Washington, DC, and;

Whereas, thousands of innocent Americans were killed and injured as a result of these attacks, including the passengers and crew of the four aircraft, workers in the World Trade Center and in the Pentagon, rescue workers, and bystanders, and;

Whereas, these cowardly acts were by far the deadliest terrorist attacks ever launched against the United States, and, by targeting symbols of American strength and success, clearly were intended to intimidate our nation and weaken its resolve, and;

**Whereas**, these horrific events have affected all Americans. It is important that we carry on with the regular activities of our lives. Terrorism cannot be allowed to break the spirit of the American people, and the best way to show these cowards that they have truly failed is for the people of the United States and their counties to stand tall and proud,

**Therefore be it resolved**, that the governing body of Boone County, Missouri condemns the cowardly and deadly actions of these terrorists, and;

**Be it further resolved**, that the governing body of Boone County, Missouri supports the President of the United States, as he works with his national security team to defend against additional attacks, and find the perpetrators to bring them to justice, and;

Be it still further resolved, that the governing body of Boone County, Missouri

recommends to its citizens to support relief efforts by giving blood at the nearest available blood donation center.
