The meeting was called to order at 9:30 a.m.

Subject: Purchasing Department

Melinda Bobbitt, Purchasing Department Director, was present on behalf of these items.

A. Second Reading and Award of Bid 76-10DEC02 (Rock and Chip Seal Term and Supply – Areas Two and Three)

Melinda Bobbitt stated the recommendation the Public Works Department is for award to Boone Quarries for Areas Two and Three.

Commissioner Miller moved to award bid 76-10DEC02 for Rock and Chip Seal Term and Supply for Areas Two and Three to Boone Quarries.

Commissioner Schnarre seconded the motion.

There was no discussion and no public comment.

B. Second Reading and Award of Bid 89-20DEC02 (Chevrolet Impala Police Vehicles)

Melinda Bobbitt stated the recommendation for award from the Sheriff's Department is to Don Brown Chevrolet for 2 2003 Chevrolet Impala Police Cars for a total contract price of \$34,414.80.

Commissioner Miller moved to award bid 89-20DEC02 for Chevrolet Impala Police Cars to Don Brown Chevrolet.

C. Second Reading and Award of Bid 88-10DEC02 (Vehicle Preventative Maintenance)

Melinda Bobbitt stated the recommendation for award from the Sheriff's Department is to Squeaky Lube for \$20.95 per maintenance visit. The Department budgets \$21,000.00 per year for vehicle maintenance services. This is a term and supply contract.

This includes delivery, installation, training and maintenance for three years.

Subject: Sheriff's Department – First Reading of Contract

Major Warren Brewer was present on behalf of this item.

Major Brewer stated this is a contract with Dr. James Allen, who is the physician contracted for jail medical care. Under Dr. Allen's license, the nurses are able to accomplish greater treatment then they would on their own. Dr. Allen has had a contract for several years and this is the first increase he has requested. This increase was approved in the 2003 budget.

Commissioner Elkin asked how much the increase is. Major Brewer stated the increase is for \$500 per month.

Commissioner Miller stated this has been a successful program compared to the previous arrangement with the Health Department. Major Brewer stated he believes the reason for the success is the fact that the County has some control over the issue. He believes the County should begin looking forward to the future because Dr. Allen may retire within the next few years.

Commissioner Miller stated the successful aspects of the program should be identified so if the Health Department does have to take over the program then maybe it can be as successful as the current program.

A. Second Reading and Approval of Change Order #1 for Bank Stabilization Projects

Commissioner Miller moved to approve Change Order #1 for Bank Stabilization Projects.
