5. Commissioner Reports

Commissioner Elkin stated he got calls from the Fair Board after the torrential downpours. There were some drainage issues at the fairgrounds. The design of the lake there is to be an irrigation lake. They planned on it being about a third full in July because it is usually hot and dry and they would be pumping water to the fields everyday. They did not anticipate a six inch rain, and the overflow is such that it drains under the new road down the midway of the fairgrounds. The City put a lot of resources out there Wednesday and they re-routed the drainage for the overflow down the north side of the road. Under normal situations, it will never flow like that. He stated he would like to write a letter of appreciation to the City of Columbia. At one time, there were probably about 30 or 40 people out here working on it. It was amazing how many people came out and got things going quickly.
