The meeting was called to order at 1:30 p.m.

#### Collector

Patricia Lensmeyer the Boone County Collector was present on behalf of this item.

### 1. Budget Amendment for excess tax maintenance (first reading)

Ms. Lensmeyer stated this is our normal process that the County goes through transferring the excess funds from the unfinished unbudgeted funds from the Tax Maintenance Fund in the General Revenue. Ms. Lensmeyer stated since this was going to be the first opportunity for Commissioner Robb to deal with this Ms. Lensmeyer stated she thought she would be present to explain it. Ms. Lensmeyer asked if the Commissioners would like her to answer any questions for the record.

Commissioner Elkin asked what the limit on this was.

Ms. Lensmeyer stated it is one half of the prior year's budget. Ms. Lensmeyer stated that is what is retained in the Maintenance Fund and then anything over that budget amount is transferred. Half of the prior year's budget is what can be in the fund.

Commissioner Miller asked why it was so high in '07.

Ms. Lensmeyer stated she believes it was when the County purchased the inserter and the mail machine.

Commissioner Miller stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading after the 10 day hold required for budget amendments with an appropriate order for approval.

### **Resource Management**

Derin Campbell a Manager in Resource Management was present on behalf of this item.

2. Approve the Cooperative Agreement with the City for Pavement Preservation for Richland Road, Bethel Church Road, St. Charles Road, Hickam Drive, Hickam Court, Bethel Drive, and Old Plank Road (first and second reading)

Mr. Campbell stated this is a cooperative agreement between the County and the City over these roads. We are going to be doing some striping work and some chip seal operations. Mr. Campbell stated the County and the City are also cooperating on some of the costs associated with Richland Rd.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the Road Maintenance Cooperative Agreement between Boone County, Missouri and the City of Columbia, for Richland Road, Bethel Church Road, St. Charles Road, Hickam Drive, Hickam Court, Bethel Drive, and Old Plank Road. The terms of this agreement are stipulated in the attached contract. It is further ordered the Presiding Commissioner is hereby authorized to sign said cooperative agreement.

Commissioner Miller stated she asked Bob Davidson the County's Facility Maintenance Director to work with Melinda Bobbitt from Purchasing and find some contractors that do hard landscape planning. Commissioner Miller stated this will be transitioned from the fountain to the planters as well, an RFP discussion.

Commissioner Robb stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.
