



To allow a concrete taper in addition to the drive entrance to allow bus traffic to transition from the existing New Haven Road pavement. It would allow construction of an entrance drive with 38ft plus a 10ft entrance radius on each side for a total pavement width of 58ft at the edge of the proposed taper.

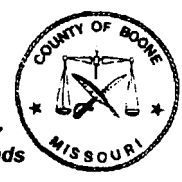

WITNESSETH, that the said Grantor in consideration of the sum of ONE DOLLAR and other valuable considerations paid by the said Grantee, the receipt of which is hereby acknowledged, does by these presents, Remise, Release, and Forever Quit Claim, unto the said Grantee any interest that the Grantor may have in the following described real estate, lying, being and situate in the City of Columbia, County of Boone and the State of Missouri, to-wit:

ALL OF THE EASEMENTS DESCRIBED BY THE DOCUMENTS RECORDED IN BOOK 1664, PAGE 113, BOOK 1677, PAGE 161 AND BOOK 1677, PAGE 163, LOCATED IN THE NORTHEAST QUARTER OF SECTION 10, TOWNSHIP 48 NORTH, RANGE 12 WEST, COLUMBIA, MISSOURI. SAID EASEMENTS WERE EXECUTED TO SERVE LAKE OF THE WOODS SOUTH PLAT 1, RECORDED IN PLAT BOOK 34, PAGE 112. PART OF SAID LAKE OF THE WOODS SOUTH PLAT 1 HAS BEEN ABROGATED ACCORDING TO CITY OF COLUMBIA ORDINANCE NO. 017817, DATED SEPTEMBER 2, 2003, THEREFORE THE EASEMENTS ARE NO LONGER NEEDED SO THEY ARE HEREBY RELEASED.



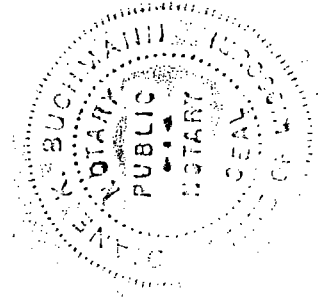
