GEOMORPHIC STREAM ASSESSMENT AND TRAINING GRANT AGREEMENT

This agreement, dated the 13th day of December, 2007, is made and entered into by and between Boone County Missouri, a political subdivision of the state of Missouri through its County Commission, herein "County" and the City of Columbia, Missouri, a municipal corporation, herein "Applicant".

WITNESSETH:

WHEREAS, the County has grant funding available under the Land-Use Planning and Water Quality Restoration in Bonne Femme Creek Watershed grant it is administering (herein "grant funds") to provide various individuals, governments, and organizations within Boone County with monies for storm water management projects and related activities designed to protect water quality within the Bonne Femme Creek watershed, and

WHEREAS, the Applicant has made a grant application with the County for use of the grant funds to fund part of the cost of a geomorphic stream assessment and related training as shown in the attached and incorporated proposal dated June 15, 2007, submitted to City by Intuition & Logic (herein called the proposal and marked as Attachment 1). The work will assess Gans and Clear Creeks downstream of Highway 63, and Little Bonne Femme Creek inside of Rock Bridge Memorial State Park. Applicant shall map any suspicious discharges and apparent outfalls.

WHEREAS, the County is willing to provide grant funding to the Applicant under certain terms and conditions to pay for work to be performed under the proposal, and

WHEREAS, both parties desire to memorialize the terms and conditions of their agreement with respect to funding for the work under the proposal.

NOW THEREFORE IN CONSIDERATION of the mutual undertakings and agreements herein contained the parties agree as follows:

- 1. The County hereby agrees to reimburse the Applicant 60% of the cost of services provided under the proposal, not to exceed the sum of Twenty Thousand Five Hundred Twenty Dollars (\$20,520.00) for use in the completion of the work described in the proposal. No additional reimbursement above this amount for additional services under the proposal shall be permitted without the prior written approval of County. Reimbursement shall be conditioned upon submission to County of payment documentation required under its grant agreement with the EPA and MDNR.
- 2. In consideration of the payment and receipt of the funds specified in paragraph 1 above, the Applicant agrees to abide by the following general terms and conditions:
 - a. The Applicant shall expend the funds received from the County under this agreement solely to pay for the expenses for work performed under the proposal described above unless otherwise approved in writing by amendment to this agreement.
 - b. The Applicant agrees that it shall submit to an audit by the county auditor or its designated contract auditor, or other audit or information request submitted to County by the EPA or MDNR upon request for purposes of determining whether the funds received by the Applicant from the County under this agreement have

- been expended in compliance with this agreement.
- c. The Applicant agrees that it shall reimburse the County for any funds paid to it under this agreement which are expended in violation of this agreement or applicable law, rule or regulation.
- d. It is agreed that the Applicant shall comply with all applicable rules, regulations and policies applicable to use and expenditure of grant funds promulgated by the EPA or MDNR applicable to the grant funds.
- e. Applicant shall submit to County all data and reports, in electronic format, related to the work completed under this agreement.
- f. A County representative shall participate in all meetings between Applicant and Intuition and Logic.
- 3. All work to be performed under the proposal shall be completed by April 15th, 2008. Applicant shall submit all invoices for the work to Boone for reimbursement under this agreement by May 1st, 2008; provided, however, that these deadlines may be extended up to 60 days upon mutual agreement by Boone and Applicant.
- 4. The signatories to this agreement by signing this agreement represent that they have obtained authority by order, ordinance, resolution or other authorization to enter into this agreement on behalf of the respective parties hereto and bind such parties to all terms and conditions contained herein.



Agreement for Cost-Share For establishing a vegetated riparian corridor

Applicant Name: William Johnson (Grantor for recording purposes)

Applicant address: 1106 Yiotis Way, Columbia, MO 65203

Property Legal Description: Lots Thirty-four (34) and Thirty-five (35) of VICTORIA SOUTH PLAT TWO (2) as shown by Plat of said subdivision recorded in Plat Book 34, Page 78, Boone County Records.

A subidivision of a tract of land in the Northwest Quarter (NW 1/4) of the Northwest Quarter (NW 1/4) of Section Eleven (11), Township Forty-seven North (47N), Range Thirteen West (13W), Boone County, Missouri, being part of that land described by a Warranty Deed recorded in Book 1357, Page 982 of the Boon County, Missouri Records and being more particularly described as follows:

BEGINNING at the Northwest corner of the Northeast Quarter (NE ¼) of the Northwest Quarter (NW ¼) of said Section Eleven (11); thence South 0°00'50" West, along the Quarter Quarter Section line 513.90 feet to the North line of Victoria South Plat Two (2); thence South 73°01'40" West, along the North line of Plat Two (2), 382.55 feet to the West line of the Survey recorded in Book 279, Page 382; thence North 01°28'00" East, along the West line, 624.70 feet to the North line of Section Eleven (11); thence North 89°49'30" East, along the Section line, 350.00 feet to the POINT OF BEGINNING and containing 4.67 acres, more or less.

Best Management Practices (BMPs) to be installed: Planting a riparian buffer.

Lifespan of practice: These practices must be maintained for 15 years from the time of installation.

Description of Practices: William Johnson will install a vegetated riparian corridor along the east side of the unnamed tributary that runs through his property. It will help to stabilize the creek's streambanks, thereby decreasing the sediment input into the creek. In addition, it will provide shade and energy for the aquatic organisms.

The County of Boone (hereafter, 'Boone' and Grantee for recording purposes) and William Johnson and his successors or assigns in title to the property upon which the practice is installed (hereafter collectively called "Applicant") agree to the following terms and conditions:

- 1. The financial assistance provided is part of a cost-share project, with 60% of the cost to be provided by Boone, and 40% of the cost to be provided by Applicant in cash from non-federal sources, labor (volunteer labor valued at the federal rate of \$17.19/hr.), equipment and materials. The specific items in this conservation practice that are eligible for cost-share are the material, labor, and equipment to establish a vegetated riparian corridor.
- 2. The vegetated riparian corridor shall be properly maintained for 15 years following completion of installation in accordance with this contract. It will require occasional weeding. Applicant agrees that Boone officials shall have the right to enter the property upon which the practice is situated during reasonable times for the purpose of inspecting the practice to verify

that it is functioning in accordance with this contract. Applicant shall keep and maintain written records of practice maintenance and provide these records to such officials upon request.

- 3. The practices shall not be removed, altered, or modified so as to lessen its effectiveness or the purpose for which the conservation practice was installed, without the consent of Boone.
- 4. The vegetated corridor's plant selection and material (see Attachment 1) has been finalized by a Missouri Department of Conservation Forester, and approved by Boone. The corridor will be established a minimum average width of 50 feet, starting from the top of the stream bank (buffer area shown in Attachment 2).
- 5. Following is a budget for the project for which the following estimates are not to be exceeded. Boone will only pay 60% of the Total Cost:

- 6. The vegetated riparian corridor will be completed by April 15th, 2008. Applicant will submit all invoices for the work to Boone by May 1st, 2008. Both of these deadlines may be extended up to 60 days upon mutual agreement by Boone and Applicant.
- 7. Applicant must pay for all material and labor before receiving reimbursement from Boone. Applicant must provide documentation to the reasonable satisfaction of Boone detailing how they have satisfied the 40% match before they will be reimbursed by Boone. Any labor or materials to be counted as match shall be documented in the form of written records with the date and total time and labor used; the quantity and price/quantity for each of the materials; and the date, duration and value/time equipment was used.
- 8. Any reimbursement costs claimed by Applicant are to be supported to the reasonable satisfaction of Boone by documentation from vendors, contractors, or other workers.
- 9. Boone officials must inspect the installation work to ensure it is completed as planned before funds are disbursed.

The Applicant understands that before receiving any funds it will be necessary to sign this agreement and agree to the terms and conditions contained in it. This agreement is intended to run with the land and be binding upon the Applicant and the Applicant's successors and assigns in title for the duration of the 15 year term after installation work is completed for purposes of maintaining practice as installed and will be recorded with the Boone County Recorder of Deeds for that purpose. However, this agreement itself is not intended to constitute a lien upon the Applicant's property nor to have priority over any lien or security interest in the property, but shall be specifically enforceable with respect to the maintenance requirements specified in the agreement.
