Boone County Regional Sewer District

Tom Ratermann and Andy Lister, Boone County Regional Sewer District, were present on behalf of this item. Mary Ellen Lea, City of Columbia, was present on behalf of this item.

1. Presentation on April Bond Issue

Mr. Ratermann and Ms. Lea made a presentation on the County and City sewer bond issues that will be on the ballot in April. These bonds are to be used to fund the improvements required by the new federally mandated regulations. Commissioner Miller stated she supports both bond issues. She stated these improvements are required, and it is more cost effective for the customers if the improvements are paid for by utilizing bonds.

9. Commissioner Reports

Commissioner Miller reported on the following:

Courthouse Expansion Project Monthly Report: The project is finishing the fifth of a fifteen month construction duration. Construction has concentrated on the building roof and exterior, working to achieve a weather tight space. In spite of the weather work moved forward and progress was made on the following:

- The fourth floor concrete slab was poured out by working to heat and temporarily enclose the work space.
- The final pieces of steel and deck were set allowing insulation on the roof and exterior dense glass sheeting to begin.
- Other items installed this month include the roof wood blocking, roof drains, skylight knee wall, and roof hatch.

However, cold and snow have pushed the schedule's "weather tight" goal from the end of February two weeks into March.

Looking into March, once the building is weather tight, demolition of the existing third floor will begin. On fourth floor, new walls and partitions will begin and the mechanical, electrical and plumbing contractors will rough in above the ceiling.

The project overall schedule is still tight due to initial steel detailing and weather delays; the current schedule shows completion January 14th 2009.

Currently, the project contingency is \$604,912.
