#### **Juvenile Justice Center**

Pete Schmersahl, Juvenile Justice Center, was present on behalf of these items.

## 1. 2007-JABG-LG-03 Award for Contract

#### 6. Commissioner Reports

Commissioner Elkin reported on the following:

**Boone Hospital Center:** Commissioner Elkin stated the new parking garage at Boone Hospital should be completed by February. He stated they are also working with the City of Columbia to get some temporary approval for parking because they are getting ready to start the patient tower, which will eliminate all of the handicap parking in the front of the building. He stated when they start the new tower, the main entrance is going to be gone, so they are going to route everyone through the Center for Advanced Medicine. There will have to be improved signage directing people because the hospital is already confusing as it is.

Commissioner Elkin stated healthcare in general is taking a hit with the economy the way it is. People are choosing not to have procedures done, which is cutting into revenue. They have lost a couple of cardiologists. He stated Barnes Jewish has 13 hospitals and 6 of them are losing money right now.

Commissioner Miller reported on the following:

**Courthouse Expansion:** Commissioner Miller stated tonight the fire department will inspect the alarm system and sprinklers for the third floor. She stated we are anticipating moving Thursday and Friday. The following week we intend to move to the fourth floor.

Commissioner Elkin asked what the final verdict was on the elevator.

Commissioner Miller stated the final number for the drilling company was \$34,190. She stated they sleeved it all the way down to 54' and then hit rock. They drilled through the rock until 58'.

They got into some clay and hit some steel. The steel was the cap from the end of the casing. She stated everything is going along pretty well.
