The meeting was called to order at 9:30 a.m.

Commissioner Miller served as Acting Presiding Commissioner in Commissioner Pearson's absence.

## **Family Court Services**

Rick Gaines, Family Court Services, was present on behalf of this item.

## 1. Fostering Court Improvement Grant

Mr. Gaines stated the Fostering Court Improvement Grant is a \$3,000 grant that we are asking for from the Office of State Court Administrators. This grant is for the purpose of having permanency for children in foster care. The County is one of nine pilot projects for the State. The State has granted us funding. There is no County match. The idea really is to come up with plans that will shorten the stay of children in foster care and more quickly get them to a permanent home.

Commissioner Miller asked what they do with the cameras that are listed on the budget request.

Mr. Gaines stated they are used to take pictures of the children with their birth families so they will have that as a keepsake later in life if they ever request it. They are kept in a safe place until the children are at a point in their life where they want to come and find out more about their parents.

Commissioner Miller stated they pictures aren't given to the children; they are kept at the Juvenile Office.

Mr. Gaines stated the children's division usually keeps them.

Commissioner Elkin asked if all of the data and outcomes are collected locally. He asked if the State places thresholds on placement and then we send them our data.

Mr. Gaines stated that is correct. He stated we are one of the pilot sites because our numbers show that we are outside of the norm when it comes to other state juvenile offices. He stated our

numbers are higher because of our central locations. We are trying to reduce numbers of kids that are in foster care and how long they stay there.

Commissioner Miller stated this is just a report and it doesn't need any action.

Mr. Gaines stated that is correct. He stated in the past they were just doing these grants without notifying the Commission, and they thought that was not the proper process.

Commissioner Miller stated we like to keep track of all the grants that are out there for the audit system, because if there are any federal dollars it has to go through the federal audit system. The only way to know that is if it comes here.

Commissioner Miller asked Commissioner Elkin thinks the Commission should make a motion accepting the report to make it easier for the Auditor to track it.

Commissioner Elkin stated he thinks that would be a good idea.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby accept the report from Family Court Services regarding the Fostering Court Improvement JCIP Sub-Grant: Local Court Enhancements.

Commissioner Miller seconded the motion.

Mr. Martin stated this is a similar situation as the Traffic Unit Grant. The way the fiscal year break is for the State versus the County, we are playing catch up.

Commissioner Miller stated we have already paid these reimbursements; we just didn't have the income yet.

Mr. Martin stated there were some line items that we asked for in the grant that the grant didn't allow that we had to realign somewhere else.

Commissioner Miller stated the budget amendment is in the amount of \$92,837 for the Mid Missouri Internet Crimes Task Force.

Commissioner Miller stated this is a first reading and requested the Deputy County Clerk schedule this item for a second reading at the next available commission meeting following the mandatory 10 day waiting period with an appropriate order for approval.
