The meeting was called to order at 9:30 a.m.

Prosecuting Attorney's Office

The Prosecuting Attorney Dan Knight and Bonnie Adkins were present on behalf of this item.

1. Budget Revision for Emergency Funds (first reading)

Dan Knight stated the Prosecuting Attorney's Office is asking for \$5,522.00. This is a request for special Prosecuting Attorney's fees and trial expenses such as the deposition transcript expenses. The primary portion of this is for the special Prosecuting Attorney.

Commissioner Miller asked why there was a special prosecutor on this?

Mr. Knight stated from time to time there is a conflict of interest from their office for whatever reason; a motion needs to be filed with the Circuit Court to appoint a special prosecutor. It is up to the presiding Judge to determine who that case is assigned to.

Commissioner Miller asked if there is a set amount that is paid to those special prosecutors or if they can just charge whatever they want?

Mr. Knight stated there is no set amount and he is hoping in the future that the County would not incur this type of expense.

Commissioner Pearson stated they do the work and then bill the County, correct?

Mr. Knight stated yes.

Commissioner Miller stated this is clean up from last year correct?

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

Circuit Court

Casey Forbis from the Circuit Court was present on behalf of this item.

2. Adult Drug Court Discretionary Grant Program (first and second reading)

Ms. Forbis stated the Circuit Court had applied for this grant last year and they are applying again this year. This is with the Bureau of Justice Assistance and the County is requesting funding to fund the Reintegration Court Coordinator's position for two years and for an addition substance abuse treatment award. As required there is a 25 % match but the Court is going to be able to find in house funds in addition to state funds to cover this.

Commissioner Pearson asked if this was a continuing grant?

Ms. Forbis stated this is a two year grant.

Commissioner Elkin asked how much the participants would pay?

Ms. Forbis stated \$50.00 a month.

Commissioner Elkin stated so every participant pays a flat fee of \$50.00.

Ms. Forbis stated yes. They adjusted it from last year which was \$30.00.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the grant application by the Circuit Court for the Adult Drug Court Discretionary Grant Program number CFDA # 16.585 in the amount of \$192,940.96.
