District II Commissioner Skip Elkin was absent.

The meeting was called to order at 9:31 a.m.

Auditor

1. Fiscal and Budget Policies (first reading)

Boone County Auditor June Pitchford was present on behalf of this item. Ms. Pitchford stated the proposed fiscal and budget policies represent the culmination of work over the last 11 months. Ms. Pitchford stated this began around March or April of 2011, and in many respects just formalizes many policies that have already been in place for a number of years. Ms. Pitchford stated there are a few items that represent new, or more firmly articulated policies. Ms. Pitchford stated one of these is the minimum fund balance relative to major operating funds. Ms. Pitchford stated she met with the Treasurer and Commission last year to complete an analysis of cash flow requirements in the major operating funds, to help identify a minimum target fund balance to maintain. Ms. Pitchford stated they arrived at two months of operating expenses, which is approximately 17%. Ms. Pitchford stated this is a more clearly articulated policy. Ms. Pitchford stated in the past the policy identified a range. Ms. Pitchford stated the policy does not require any specific course of action, but simply states that if fund balances are projected to fall below the minimum amount, the County will develop a plan to restore the fund balance. Ms. Pitchford stated they believe this is important because it gives the County Commission the flexibility to determine the appropriate course of action given the circumstances in any given year. Ms. Pitchford stated the other item that is more clearly articulated has to do with grants. Ms. Pitchford stated there has been an unwritten preference to have grant applications approved by the County Commission before they are submitted. Ms. Pitchford stated the new policy clearly states this. Ms. Pitchford stated this is helpful so the County can identify local match requirements and ongoing obligations. Ms. Pitchford stated there is a statement that the County will look to the overall revenue and expenditure forecast environment. Ms. Pitchford stated the County will develop a multi-year revenue and expenditure forecast to be used in conjunction with the annual budget process. Ms. Pitchford stated this is something that the County has been doing, and has not been formally recognized before this point.

Commissioner Miller confirmed the statement that by state law, emergency funds require a unanimous vote by the County Commission.

Ms. Pitchford stated yes.

Commissioner Miller stated she didn't realize that, but it's always a unanimous vote anyway.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available Commission meeting with an appropriate order for approval.

Sheriff's Department

2. Budget amendment to account for expenses and revenue related to the contract for MU Security (first reading)

Boone County Sheriff Dwayne Carrey and Boone County Auditor June Pitchford were present on behalf of this item. Ms. Pitchford stated each year when they develop the budget for the Sheriff's Department; we anticipate a renewed contract for the MU football security. Ms. Pitchford stated there is no way to project how many officers will volunteer, or how many hours they will work. Ms. Pitchford therefore, they don't know how much in the budget to include as an expense or as revenue for when we're reimbursed. Ms. Pitchford stated in prior years, even though officers worked, the budget didn't need to be amended the increase the spending capacity. Ms. Pitchford stated in needs to be done this year. Ms. Pitchford stated the budget amendment recognizes the actual expenses incurred under the contract, and the reimbursed revenue the County receives.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading after the 10 day hold required for budget amendments with an appropriate order for approval.
