SUBJECT: Reports from Commissioners

Commissioner Miller reported on the proposed Mid-Missouri Tourism Council. The group would create a community calendar in order to coordinate the scheduling of events. The twenty member board would represent groups which bring in tourists. The group would also develop new promotions. Each entity represented on the board would contribute \$100 to fund start up costs such as opening a post office box and creating and distributing an initial mailing. Memberships will eventually be solicited. The group will be a corporation with by-laws.

The Commission agreed they are interested in participating.

Mr. Patton stated in order to provide funding, the County needs to determine whether to purchase an organizational membership or contract for economic development activities.

Commissioner Miller reported the Boone Retirement Center (BRC) Board is working on the schematic design for their new building. HUD requires a contractor be hired to provide cost control services as the architect designs the building. The project needs to be open to all contractors. She agreed to provide the County's list of contractors.

Commissioner Stamper reported he met with Nick Boshard, Vice-President of Boone Hospital Center. They want to establish a new health care clinic in Centralia. They request the County participate as a partner. The cost of the 10,000 to 15,000 square foot building is about \$1 million to \$1.5 million. He advised them the Commission is interested in discussing the matter further. It might be possible to locate a satellite office there where people could conduct routine County business. An employee could be trained to provide multiple services, such as issuing a building permit, a marriage license or collecting tax payments. The Sheriff could also have a satellite operation there. Boone Hospital Center is also interested in a southern Boone County operation.

Commissioner Stamper reported he met with CRSS Construction Manager Dave D'Eagle and with the Government Center contractor, Reinhardt Construction, to discuss items remaining on the building punch list. Commissioner Stamper reviewed items which were released and the few remaining items.
