### SUBJECT: Budget Amendment: Reimbursement for Overtime, Neighborhood Improvement District Program

### SUBJECT: Park Land Lease and Contract for Purchase of Real Estate with Pinnacles Youth Foundation and Option to Purchase Real Estate and Contract for the Sale of Real Estate with Stephen L. and Letha A. Willsie

Mr. Patton stated Boone County closed the sale of property adjacent to Pinnacles Park yesterday. Pinnacles Youth Foundation agreed to a lease which gives them an option to purchase the land. The purchase price consists of the amount Boone County is paying, plus interest Boone County would have earned between the time of purchase and the time the purchase option is exercised. The term of the lease is twenty years. The Pinnacles Youth Foundation agrees to maintain the property, maintain insurance on the property and allow public use of the property for park purposes. The Willsies have a back up option to purchase the property in the event Pinnacles Youth Foundation does not exercise its option. Their property adjoins this property and they are providing the access easement.

In response to a question from Commissioner Vogt, Mr. Patton stated the access easement has been granted. They planned to record it yesterday.

Commissioner Vogt moved that the County Commission of the County of Boone approve the attached PARK LAND LEASE and CONTRACT FOR PURCHASE OF REAL ESTATE with the Pinnacles Youth Foundation and OPTION TO PURCHASE REAL ESTATE AND CONTRACT FOR THE SALE OF REAL ESTATE with Stephen L. and Letha A. Willsie.

Commissioner Miller seconded the motion. Motion passed unanimously. Order 293-96.

Commissioner Miller reported she toured the old Juvenile Justice Center. The building is being used to house those operating the Caring Communities program, the alternative school and for preschool hearing screenings.
