The regular meeting of the County Commission was called to order at 1:30 p.m.

## SUBJECT: Contract with Richardson and Bass for Hot Bituminous Asphalt Mix

Purchasing Department Director Beckie Jackson reviewed her memorandum to the commission dated December 17, 1996.

Commissioner Miller moved that the County Commission of the County of Boone award Mid-Missouri Public Purchasing Cooperative Bid MM12 to Richardson and Bass Construction Company. The County Commission does hereby approve, and authorize the Presiding Commissioner to sign, the attached agreement.

Commissioner Vogt seconded the motion. Motion passed unanimously. Order 1-97.

#### **SUBJECT:** New Haven Meadows Neighborhood Improvement District Change Order One

Neighborhood Improvement District Coordinator Andy Lister stated the first 400 feet of Roseta Drive had completely disintegrated. The plan was to remove and replace the concrete. Upon removal of the concrete they discovered the subgrade was also bad. This change order will cover the cost of removing one foot of the subgrade from the first 400 feet of the road.

Commissioner Vogt moved that the County Commission of the County of Boone approve, and authorize the Presiding Commissioner to sign, New Haven Meadows Neighborhood Improvement District Road Improvement Project Change Order One. (Contract 89-03OCT96)

Commissioner Miller seconded the motion. Motion passed unanimously. Order 2-97.

## SUBJECT: 1996 Public Works Department Budget Revision: Salaries and Wages

Public Works Department Director Frank Abart stated this revision is necessary due to hiring an Engineering Technician at seven percent above the base of the salary range, using the New Hire and Starting Rate of Pay Policy, and hiring a Staff Engineer at the reclassified range 26. This request was reviewed by the Human Resources Department and Auditor.

Following discussion, Commissioner Stamper moved that the County Commission of the County of Boone authorize the following budget revision:

## SUBJECT: U.S. Department of the Treasury Federal Equitable Sharing Agreement

Sheriff Ted Boehm stated the Department has had such an agreement since he has been Sheriff. When the Department and a federal agency seize money or property, both agree to share the

assets. This agreement requires the signature of the Presiding County Commissioner. The agreement will remain in effect until September 30, 1999.

Commissioner Vogt moved that the County Commission of the County of Boone approve, and authorize the Presiding Commissioner to sign, the attached Federal Equitable Sharing Agreement between the Boone County Sheriff's Department and the United States Department of the Treasury, pending approval as to form by legal counsel.

Commissioner Miller seconded the motion. Motion passed unanimously. Order 4-97.

## **SUBJECT: Community Policing Grant Award**

Sheriff Boehm stated he has received notification from the U.S. Department of Justice of a COPS Universal Hiring Program grant award in the amount of \$111,220 for two new, additional full-time officers. The grant amount will be disbursed over a three year period.

In response to a question from Commissioner Stamper, Sheriff Boehm replied the two new officers are not budgeted. They were unaware of the grant award prior to adoption of the 1997 budget. The county has 45 days in which to accept the award. His commitment to this grant would be for a three year period. While the federal government hopes the county will continue funding the officers upon expiration of the grant period, it is not mandatory. Sheriff Boehm stated if he reassigned officers from the jail staff to community policing, this money could be used to hire the clerks he requested during the 1997 budget process to staff the control centers in the jail.

Commissioner Stamper requested a specific proposal from the Department for the commission and Auditor to review. He is pleased the Department received the grant.

Sheriff Boehm agreed.

#### SUBJECT: 1996 Circuit Clerk Budget Revision: Workstation Modification

Circuit Clerk Cheryl Whitmarsh stated she would like to transfer excess class 6 funds to modify workstations to allow two clerks to share equipment.

Commissioner Vogt moved that the County Commission of the County of Boone authorize the following budget revision:

Commissioner Vogt reported she will participate in a 48-hour intensive internship at University Hospital beginning Sunday evening. She will not be available Monday or Tuesday.

Commissioner Vogt reported she and Commissioner Stamper attended a meeting regarding localizing social services and health agencies in order to better serve the population.
