The meeting was called to order by the Presiding Commissioner at 9:35am.

Subject: Naming of an Unnamed Roadway

Ryland Rodes stated that the Planning and Building Inspection Department received a request to name an unnamed roadway, that is currently privately owned and maintained, McGill Creek Road. He gave the description of the road as follows: Section 32, Township 49 North, Range 14 West; beginning on the north side of Highway 40 approximately 1.1 miles west of State Route J and running in a northerly direction for approximately 1600 feet; further described as Tract 7 as shown on a survey recorded in Book 1490, Page 850 of Boone County Records.

Commissioner Miller asked if these were all 5-acre tracts.

Ryland Rodes stated that the tracts are 5 acres or larger.

Commissioner Miller asked if the property owners would want the County to take over maintenance of the road at some point.

Ryland Rodes stated that he did not believe so.

Commissioner Vogt moved to approve the request to name an unnamed roadway, as described in the attached documents that is currently privately owned and maintained, McGill Creek Road.

Commissioner Miller seconded the motion.

There was no discussion.

The motion passed 3-0. Order 49-2000

Subject: Approve an Agreement for Imaging Services with Word-Tech, Inc.

Bob Ormiston stated that this is an agreement to begin the process of replacing the existing imaging system. He stated that the agreement defines the exact scope of the work that Word-Tech will perform for the County. He stated that the agreement includes installation and systems integration of new software, hardware and conversion of the old images to work within the new system.

Commissioner Miller stated that this agreement is actually for an upgrade to the existing system. She stated that Optica, which is the system that the County currently uses, is still the best imaging system on the market. She stated that the problems that the County has been experiencing are related to integration, not the system.

Bob Ormiston concurred with Commissioner Miller's comments.

Commissioner Miller stated that they still needed to discuss how this agreement would be paid for. She stated that Bettie Johnson, Recorder of Deeds was very open to helping with the costs

of this project.

Commissioner Miller asked if Bob Ormiston was requesting that the agreement be approved, pending the funding allocations being worked out through the Auditor's Office.

Bob Ormiston answered affirmatively.

Commissioner Stamper stated that there was no completion date stated in the agreement.

Bob Ormiston stated that Word-Tech indicated that the completion date would be 120 work days/160 calendar days from the start date.

There was agreement to July 1, 2000 being the completion date.

Commissioner Miller stated that the County received contact from 5 representatives of Word-Tech and they were all very knowledgeable.

Commissioner Miller moved to approve the Agreement for Professional Services between Boone County and Word-Tech, Inc. pending certification by the Auditor's Office and further authorize the Presiding Commissioner to sign the agreement.

Commissioner Vogt seconded the motion.

Frank Abart stated that this report outlines some of the significant work that was performed by Engineering Surveys & Services for the County. He stated that E S & S was hired to investigate 151 sites throughout the County at a not to exceed amount of \$35,000. He stated that E S & S was asked to place each site in one of the following categories: High, Medium, Low, or No corrective action needed. He stated that the break down was as follows: No action needed-18, Low-83, Medium-44, High-6.

Frank Abart stated that of the six sites that were listed as High Priority, three sites (Varnon School Rd, River Rd, and Zumwalt Rd Bridge) have already been worked on or are in the process of being replaced. He stated that the other three sites are Durk Rd, Maupin Lane, and Pinnacles Rd, which the County is pursuing with Harrington & Cortelyou for a Bridge Engineering Assistance Grant through the MO Department of Transportation.

Frank Abart stated that the Public Works Department would be pursuing MO Department of Natural Resources funding to make the necessary corrections to the other bridge sites in the next 12-18 months.

The County Commission accepted the report for the public record.

Subject: Community/Social Service Agreements for Pyramid Homemaker Services and the Northeast Community Action Corp

Commissioner Vogt stated that these agreements are a recommendation forwarded by the Community Services Advisory Commission.

Commissioner Vogt moved to approve the Community/Social Service Agreement for the year 2000 between Boone County and the following agencies: the Northeast Community Action Corp and Pyramid Homemaker Service, Inc. It is further ordered that the Presiding Commissioner be hereby authorized to sign the agreements.

Commissioner Miller seconded the motion.

There was no discussion.

The motion passed 3-0. Order 51-2000

Subject: Consent for proposed assignment of Capital Cable's assets to Charter Cable

County Counsel John Patton stated that this franchise was established in 1981 with Boone County Cable. He stated that Boone County Cable's franchise rights were transferred to CableAmerica. He stated that Falcon Cable bought out CableAmerica. He stated that the franchise is now in the hands of the Falcon/Capital Cable partners which is seeking to transfer those rights to Capital Cable/Charter Communications.

John Patton stated that the only issue that he recalls ever coming forward about this company is whether or not Falcon/Capital Cable was paying the 3% gross revenues, franchise fee. He stated that he was not aware of the status of that issue, however the document that the County Commission would sign for the assignment stated that the company was up-to-date in the paying of their fees.

Commissioner Stamper asked: who is the collection source for those fees?

John Patton stated that he assumed the County Treasurer would collect those fees.

Commissioner Stamper suggested the County Commission review the existing franchise agreement before making a decision on this matter. He stated that they should check with the County Treasurer to make sure that the 3% fee was paid over the years.

Commissioner Miller stated that she would like to have the right-of-way issues addressed before this matter is settled. She stated that she would like to "have it where the cable company is not in our (County) ditch." She stated that she would like to have an agreement with the cable company that would require them to obtain permits as other entities have to do. She stated that she would like to give the cable company a "heads-up" of what is required in Boone County as opposed to other counties.

John Patton stated that the original franchise agreement of 1981 does permit the cable company to use the County right-of-way and construct their facilities consistent with the City ordinances for cable television.

Commissioner Stamper requested copies of the existing franchise agreement in order to hold a work session with John Patton to discuss the matter.

Subject: Nuisance Ordinance

John Patton stated that he needed guidance from the County Commission on a letter he received from the City of Columbia concerning the revisions to the Nuisance Ordinance. He stated that the city of Columbia suggested that they eliminate the complaint process. He also stated that they suggested that the application to the 25-lot subdivision be changed to one of three options: reduced to five lots or more, the number be left out of the Ordinance all together, or that A-1 zoned property be excluded entirely. He stated that he did not know if the A-1 option would work because there are a lot of A-2 properties that have undeveloped farms on them. He stated that when the County underwent this process a couple of years ago the big complaint was that the farmers did not want to be subject to weed height regulations, etc. He asked the County Commission to determine which option they would like to choose.

Commissioner Stamper asked if land that is used principally for agricultural services could be excluded.

John Patton stated that by using this definition however, it would create a gray area of "what is principally agricultural?"

The County Commission agreed to work toward using the term principally agricultural in that

section of the Nuisance Ordinance.

Commissioner Reports

Commissioner Stamper

Commissioner Stamper stated that he had an informal discussion with a member of the Burnam family yesterday. He stated that Mr. Burnam had some ideas about adjusting his request for the Windy Point Development CUP. He stated that he informed Mr. Burnam that any major reconfiguration would have to go through the Planning and Zoning Commission again. He stated that he did want to report on the conversation because he believed that it revealed that the Burnams are working and looking at all of the options. He stated that the Windy Point matter is scheduled for discussion in County Commission on February 29th. He stated however that he was not sure whether the Burnams would choose to re-evaluate their position by that time or not.

Commissioner Stamper stated that there is a work session coming up on the Fairgrounds to discuss a variety of issues.

Commissioner Stamper stated that he attended a meeting at the Senior Center about a week ago and received the impression that there is some confusion as to what the Community Services Advisory Commission did with the previous funding level. He stated that there were a lot of references to the \$15,000.

Commissioner Vogt and Commissioner Stamper agreed to try to clarify the matter.

Commissioner Stamper reported that he had a discussion with a representative of the City of Columbia concerning an ice proposal for the old Fairgrounds site on Clinkscales. He stated that the representative asked if the County had any plans to construct an ice facility at the Boone County Fairgrounds. He stated that he informed the representative that the County received numerous proposals for an ice facility, however that the County has no specific plans at this time.

Commissioner Stamper stated that the City and County should consider a joint venture, if the County decides to construct an ice facility.

Commissioner Stamper stated that the County Commission should forward its response on the Metro 20/20 Plan to the mayor of Columbia this week.

Commissioner Stamper stated that most of his day yesterday was spent in interviews for the REDI position. He stated that there are three final candidates for the position. He stated that Ray Beck, City Manager will handle the negotiations for the position from this point forward.

Commissioner Miller

Commissioner Miller reported that the Mental Health Board of Trustees met yesterday. She stated that the next big event is the recognition of May as "Mental Health Awareness Month." She stated that the trustees intend to put on a program for civic groups entitled *Myths & Facts about Mental Illness*. She stated that a lady from the State was present to discuss other counties' activities in this area.

Commissioner Miller stated that they also discussed the RFP for Mental Health Services at the Boone County Jail. She stated that Beckie Jackson was finally able to locate a template of an RFP for mental health services at a Jail from a county in Virginia. She stated that Beckie Jackson is reviewing this RFP to help formulate the County's RFP. She stated that she would forward a copy of the draft RFP for Mental Health Services at the Boone County Jail to the County Commission later this week. She stated that later this week she would also meet with the Sheriff and the Purchasing Director in work session to discuss the RFP.

Commissioner Miller stated that she met yesterday with the economic group in Ashland. She

stated that the group is looking at the extension of the outer road on the east and west sides of Ashland.

Commissioner Miller reported that she met yesterday with the Missouri Institute of Public Policy representatives that are working with the Visioning Project. She stated that there were three cities that did not send back their stakeholders, and therefore the first meeting of the stakeholders was postponed until those lists are received. She stated that the County did not receive the Boone Electric and Stafford Foundation grants. She stated that they are still working on other sources of funding.

Commissioner Vogt asked Commissioner Miller what would happen if other sources of funding were not identified.

Commissioner Miller stated that she was not sure. She stated that there was a possibility that she would request \$5,000 from the County Commission in order to keep the process moving. She stated that she expected people to come on-board once the project is underway.

Commissioner Vogt

There was no public comment.

Commissioner Vogt reported that she is working on the Space Needs Assessment. She stated that the Court asked for an extension (until today) to turn their information in. She stated that she has been working with the County Commission staff on the County Commission Office space needs information. She stated that there would be a discussion about that information later in the Commission staff meeting.

The meeting was adjourned at 10:20am.
