# C. First Reading of Engineering Contract for Design of Judy School Road Realignment

David Nichols, Boone County Public Works, present on behalf of this item.

David Nichols stated this would be a review of the intersection of Judy School Road and Route Z. There is a consultant reviewing the realignment and subsequent design. Public Works would be working with A Civil Group, if the contract is approved. The cost of the contract is \$12,000.

Commissioner Elkin asked if this is the road just south of Two Mile Prairie Elementary School. Mr. Nichols stated that this is correct. Commissioner Elkin stated this road was realigned about fifteen years ago. This road intersected with Route Z at the crest of a blind hill. The intersection is at a skewed angle.

Mr. Nichols stated because of the skewed angle, it is difficult for vehicles to pull in and out. The intent is to make the intersection tangent to Route Z. In doing so, there will be properties affected, they are also asking for re-alignment.

*FEMA*
