## **Subject: Purchasing Department**

### A. Second Reading and award of Bid 14-30MAR04 (Lien Search Services)

Melinda Bobbitt stated this is a recommendation for award to Monarch Title Company. The total cost of lien search is \$47.48. Currently there have been 429 parcels identified. This will be paid from organization 1150 account 84500.

### **Subject: Circuit Court – First Reading of Budget Amendment**

Kathy Lloyd, Assistant to the Court Administrator, was present on behalf of this item.

Kathy Lloyd stated this budget amendment will transfer funds from 2905 into 2907 for fiber lines. The cost of this project will be shared with OSCA and the Circuit Court has entered into an agreement with OSCA. The Auditor has established a new fund, 2907, for the Court's use of fiber and the costs associated with that. There will be some funds in 2905 for equipment maintenance contracts and computer hardware for County Information Technology.

Commissioner Miller asked why a new fund has been created. Ms. Lloyd stated the Court has entered into an agreement with OSCA and this will allow the Court process the requisitions and monitor the account.

Commissioner Elkin stated this will complete the project.

Ms. Lloyd stated this will connect the Courthouse, JJC and the Jail by fiber. She noted the Court will lease a line with OSCA for the on-going use of the line. There some additional costs that were not originally budgeted in 2905 but have been added from Prop L funds to support that.

Commissioner Miller asked what the budget was. Ms. Lloyd stated \$15,564 was budget for FY2004 for this project.

Ms. Lloyd noted the Court has received some invoices from LandTel for the installation. She believes that when this is approved the invoices can be processed. They will have to work on a lease payment schedule with OSCA.

Commissioner Elkin stated it should be three to four weeks to run the lines.

There was no further discussion on this item.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting after the required 10 day waiting period with an appropriate order for approval.
