The meeting was called to order at 9:31 a.m.

#### **Subject: Purchasing Department**

Melinda Bobbitt, Purchasing Department Director, was present on behalf of these items.

### A. Second Reading and Award of Bid 16-20APR04 (Salary Plan Update)

Melinda Bobbitt stated the Request for Proposal for the Salary Plan Update closed on April 20, 2004. Three proposal responses were received.

The evaluation committee recommends award to Public Sector Personnel Consultants per their evaluation report. Total contract price of \$13,500 will be paid from department 1115 – Human Resources, account 71100 – Outside Services.

Commissioner Elkin moved to award bid 16-20APR04 for the Salary Plan Update to Public Sector Personnel Consultants.

Commissioner Schnarre seconded the motion.

## B. Second Reading and Cancellation of Bid 51-09JUL02 (Painting Services Term and Supply)

Melinda Bobbitt stated Purchasing requests approval from the commission to cancel the contract for Painting Services Term and Supply effective immediately for failure to provide proof of insurance for the renewal term. We have been in contact with Ken Hensel Painting, and he has informed us he will not be able to provide insurance until the end of July.

Commissioner Elkin moved to cancel bid 51-09JUL02 for Painting Services Term and Supply with Ken Hensel Painting for non-compliance of contract section 2.7 (failure to provide proof of insurance). Said cancellation will be effective immediately.

# C. First Reading of Bid 24-04MAY04 (Bituminous Material EA-90 and EA-90P – Term and Supply)

Melinda Bobbitt stated the bid for Bituminous Material EA-90 and EA-90P Term and Supply closed on May 4, 2004. Two bids were received. Purchasing and the Pubic Works department recommend award to Koch Pavement Solutions as low bidder when considering Year 1 and Year 2 pricing.

This Term & Supply contract will be paid out of department 2040 PW Maintenance Operations and 2041 PW Special Maintenance Projects – Pavement Repairs Material, account number 26400 Road Oil. The original budget is for \$173,867, and \$131,807 remains in the account at the time.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for award.

### D. First Reading of Bid 26-18MAY04 (Carr Lane Culvert Replacement Project)

Melinda Bobbitt stated the Public Works Department and the Purchasing Department have reviewed the bid responses for the Carr Lane Culvert Replacement Project. We recommend award to S & C Bridge & Concrete for submitting the lowest bid.

The contract award is for \$31,730 with a contingency of \$3,173.00 for a total Purchase Order amount of \$34,903.00 for department 2040, account 71100. This project is not

specifically budgeted, but is an Emergency Repair.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for award.

### **Subject: Information Technology – First Reading of Request for Fixed Asset Budget Addition**

Michael Mallicoat, Information Technology Director, was present on behalf of this item.

Michael Mallicoat stated the Sheriff's Department Mugshot printer malfunctioned and could not be repaired. Since the printer is critical to the operations of the Sheriff's Department, the Auditor's Office, with Commissioner Elkin's approval, agreed to emergency order a replacement.

The order was placed on May 21, 2004 using WSCA contract #90-00151 at a quoted price of \$702.00.

Mr. Mallicoat is requesting the Commission's approval to add this item to the Information Technology FY2004 fixed asset budget.

Commissioner Elkin asked if the printer has been received. Mr. Mallicoat stated he was not sure if the printer has arrived but is scheduled to do so by today.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

#### **Subject: Purchasing Department – Presentation of Annual Report**

The 2003 Purchasing Department Annual Report was submitted to the Public Record.

Melinda Bobbitt reviewed the departments projects, the number of contracts and amount spent on contracts in 2003. She also reviewed the Request for Proposals done in 2003.
