B. Second Reading and Award Bid 25-20MAY04 (Chip and Seal Application)

Alice Winkelman stated the bid for Chip & Seal Application closed on May 27, 2004. Four bids were received. Purchasing and the Pubic Works department recommend award to APAC-Missouri as low bidder.

This contract for \$426,304.00 will be paid out of department 2041 PW Special Maintenance Projects – Pavement Repairs Material, account number 71100. The original budget is for \$1,039,039 of which \$607,959 was estimated for Chip & Seal Application.

Commissioner Miller moved to award bid 25-20MAY04 for Chip and Seal application to APAC-Missouri.

C. First Reading of Bid 33-15JUN04 (Painting Services Term and Supply)

Alice Winkelman stated the Bid for Painting Services Term and Supply closed on June 15, 2004. Three bids were received. Upon the completion of the bid evaluation, Facilities Maintenance and Purchasing recommend award as follows for the lowest and best bids in the following order:

Secondary Supplier: Humber Painting Company Tertiary Supplier: Brighter Days! Corporation

The contract will run through June 30, 2005 with two, one-year renewals.

Subject: Juvenile Justice Center – First Reading to Accept Juvenile Accountability Incentive Block Grant (JAIBG) Award and Budget Amendment

Kirk Kippley, Juvenile Justice Center Superintendent, was present on behalf of this item.

Kirk Kippley stated this is a supplemental grant the Juvenile Justice Center has applied for and the total amount of grant is \$901.00. The County has to have a match, which is the reason for the budget amendment. This will be used to purchase up-to-date resource

materials for the victim advocate program at the Juvenile Office and purchase a 27" television for the male detention wing at the Juvenile Justice Center. The department is requesting permission to proceed with this grant.

Commissioner Miller stated she has no issues with this request. She asked where things stand with the federal legislation that will take away this funding. Mr. Kippley stated there will be some funding beginning October 1, 2005. He does not know how much funding there will be but does know the funding will be cut. The funding that will be received October 1, 2004 is ok.

Commissioner Miller asked if this bill has passed. She knows Kathy Lloyd, Court Administrator, sent a letter of concern. Mrs. Lloyd stated she faxed the letter.

Subject: Sheriff's Department

Leasa Quick, Sheriff's Department Account Specialist, was present on behalf of these items.

A. First Reading of Budget Revision

Leasa Quick stated this is a budget revision in the amount of \$330 for the purchase of a new washing machine to be used at the Boone County Jail. The washer that was in D-Pod quit working. The maintenance department looked at the washer and the parts would cost approximately \$350 to fix the washer. A new washer was \$329. This is a supplemental washer in D-Pod.
