Subject: Purchasing Department

Heather Turner, Purchasing Department Buyer, was present on behalf of these items.

Subject: Public Works – First Reading of Budget Revision

Don Abell stated this is a request for approval of a budget revision to transfer \$100,000 from the Emergency fund to the motor fuel/gasoline line item. This will cover the fuel costs for the remainder of the year.

Subject: Boone County Regional Sewer District

Tom Ratermann, Boone County Regional Sewer District Manager, was present on behalf of these items.

A. First Reading of Resolution to Authorize Filing of Rural Sewer Grant Application for Hackberry NID

Tom Ratermann stated this is a resolution authorize the Presiding Commissioner to sign the grant application for the Hackberry NID. There are seven households in this NID. The cost is approximately \$1,400 per household for a total of \$9.800.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

B. First Reading of Resolution to Authorize Filing of Rural Sewer Grant Application for Prathersville/Wagon Trail NID

Mr. Ratermann stated this is a resolution authorize the Presiding Commissioner to sign the grant application for the Wagon Trail/Prathersville NID. There are 31 connections in this NID with an approximate \$1,400 per household for a total of \$600,000. There are two connections to mobile home parks that are considered one connection. There is also another multi-family area; he believes it is a four-plex, which is also considered one connection.

There was discussion on the amount of the general obligation bonds that were authorize by voters in 1997 and the amount the county has used to date.

Patricia S. Lensmeyer, Boone County Collector, and Kay Murray, Boone County Treasurer, asked questions about how these grant funds will affect the County's bonding and the payments from the residents. Mr. Ratermann explained how the grant will work.

Commissioner Elkin asked how a rural sewer grant is different than a Community Development Block Grant (CDBG). Mr. Ratermann stated there is a difference and that a CDBG is a last resort.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.
