## 2. Purchasing

### A. First Reading 24-21MAR016 HVAC Filters Term and Supply

The Bid for HVAC Filters Term and Supply for the Facilities Maintenance Department closed March 21, 2006. Two bids were received. Purchasing and Facilities Maintenance recommend award to Brauer Supply Co. for submitting the low bid.

Total cost of contract is \$1,811.75 to be paid out of department 6100 – Facilities and Grounds Maintenance, Account number 23050 – Other Supplies. The original budget was \$2,200.00.

- Bankruptcy proceedings have intervened making the balances due uncollectible; or,
- The real estate property was not subject to taxation after being acquired by a tax exempt owner after January 1 of the taxable year.

The above total of \$143,480.03 breaks out as follows:

• Personal property \$121,714.10

• Bankruptcy \$ 14,248.43 – all personal property

• Tax exempt acquisitions \$ 7,517.50 – all real estate
