The evaluation committee recommends award to Behavioral Health Concepts per their attached evaluation report. The cost of this contract per year is \$140,532.26. Attached are Purchase Requisitions for the period June 6 – December 31, 2006 for a total of \$80,468.77 and will be paid out of department 1255 – Corrections and 2902 – Corrections LE Sales Tax, account 85620 – Other Medical. \$140,671.72 was budgeted for this contract.

We received a letter from BusComm that per their manufacturer, they may no longer be able to provide replacement parts. They are offering us this *Limited GMS Agreement* to replace the *Guaranteed Maintenance Service Agreement* to cover technical support, on-site response and replacement parts <u>as available</u> for all service calls for a cost of \$5,019.13. Maintenance will be paid out of department 2901 - Sheriff Forfeiture Money, account 60050 - Equipment Service Contract.

3. Treasurer – Amendment to Office Space Lease

Kay Murray, Treasurer was present on behalf of this item.

The lease dated June 12, 2003 made by and between Count Boonty, LLC, predecessor and assignor to Boone County, Missouri, a political subdivision of the State of Missouri, ("Lessor") and the City of Columbia, Missouri (Columbia Police Department), ("Lessee") pertaining to the second floor of 101 N. 7th St., Columbia, Missouri is amended as follows:

- 1. Paragraph 3 of the lease is revised by adding the following sentences: upon expiration of the initial term and this lease, this lease may thereafter continue on a month to month basis subject to the terms and conditions set forth in this lease. The month to month tendency thereby created may be terminable by either party for any reason upon 60 days advance written notice to the other party.
- 2. In all other respects, the office space lease agreement dated June 12, 2003 shall remain in full force and in effect.

B. First Reading – IT Upgrade AS400 System

Commissioner Miller spoke on behalf of IT.

The AS400 upgrade/replacement was scheduled for 2007. The original budget was \$30,000.00 for equipment and \$5,840 for installation and consultant fees to move the AS400 from the sheriffs department to downtown.

The AS400 at the Sheriffs department held no value because it lost support from the company. Recently new information came out that encourages companies to upgrade and stay with the platforms. The company is now offering between \$30,000.00 and \$45,000.00 for that AS400.

The staff asked to forgo the AS400 upgrade in 2007 and doing it at the same time as we are consolidating the two AS400's. We should receive between \$42,000 and \$62,000 when we consolidate the two existing AS400's that we now have. The final cost is around \$72,122.95.

The percentage of use by the Assessors office for records for the government center is 9.3962%. This will rise when we transfer everything over for Real vision. Mr. Schauwecker has agreed to pay \$10,334.00 out of the assessment fund towards the purchase.

There was no additional discussion and no public comment.
