4. Purchasing

Heather Turner, Purchasing Department was present on behalf of these items.

A. 46-29JUN06 Boone Industrial Park

Ms. Turner stated the bid for Boone Industrial Park Road Improvement Project closed on June 29, 2006. Five bids were received. Purchasing and the Public Work's department recommend award to Lehman Construction, LLC for submitting the overall low bid.

Total cost of contract is \$503,954.30 with a 10% contingency on the Base Bid only of \$38,097.50 for a total Purchase Order amount of \$542,051.80. This contract will be paid out of department 2045 – Public Works Design and Construction, account number 71100 – Outside Services. The original budget was \$350,000.00.

There was no discussion and no public comment.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

B. 45-29JUN06 Lake of the Woods Pavement & Drainage

Ms. Turner stated the bid for Lake of the Woods Pavement & Drainage Improvements Phase II closed on June 29, 2006. Three bids were received. Purchasing and the Public Work's department recommend award to Steve & Associates, Inc. for submitting the low bid.

Total cost of contract is \$346,045.70 with a 10% contingency of \$34,604.57 for a total Purchase Order amount of \$380,650.27. This contract will be paid out of department 2045 – Public Works Design and Construction, account number 71100 – Outside Services. The original budget was \$500,000.00.

There was no discussion and no public comment.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

C. 22-28MAR06 Street Name Signs

Ms. Turner reported that Purchasing requests approval from the commission to cancel the contract for Street Name Signs that was awarded on commission order 180-2006 to Subcon International. Subcon was notified on June 6, 2006 that they were non-compliant with the contract due to the delivery of signs being late; past their bid of 30 - 45 days. They have not rectified the problem.

Vulcan Signs was actually the next lowest bid, but they could not meet the specification for "inside delivery", their prices were only firm for one year, and the delivery days were 30-45 days vs. the delivery days of 15 calendar days from Kelpe's Signs. Therefore, Purchasing and Public Works recommend awarding to the next best and lowest bid meeting specifications, Kelpe's Signs and Banners.

This Term & Supply contract will be paid out of Department 2040 – PW Maintenance Operations, Account Number 26600 – Street/Traffic/Construction Signs. The budgeted amount for FY 2006 is \$56,000. \$42,333 remains in the account at this time.
