Recommendation from Personnel Advisory Committee to revise Section 2 of the Personnel Policy Manual re Employee Benefits

The Personnel Advisory Committee met on July 13, 2006 and unanimously recommends revising the introductory paragraph in Section 2 of the Personnel Policy Manual. Proposed revised wording is shown below in bold italics:

"The County Commission establishes benefits offered to Boone County employees annually through the budget process. Any County employee in a full-time or regular part-time budgeted position for at least 1,000 hours in a calendar year is eligible for benefits. These benefits may change based upon factors that sometimes cannot be predicted. Specific benefit information is included in Appendix A."

The proposed effective date of this revision is January 1, 2007.
