1. Purchasing

A. Second Reading 68-10AUG06 BCERT Tactical headsets

Commissioner Elkin moved now on this day the County Commission of the County of Boone does hereby award bid 68-10AUG06 BCERT Tactical Headsets to Atlantic Signal. It is further ordered that the Presiding Commissioner be hereby authorized to sign said contract.

C. First Reading 49-21JUN06 Patrol Rifles

Ms. Turner reported the bid for Patrol Rifles closed on June 21, 2006. Six bids were received. Captain Gary German reviewed the bids received and determined the product offered by the 2nd low bidder to be a better fit for the Sheriff's Department (see attached memo from Captain German dated June 30, 2006). Therefore, Purchasing and the Sheriff's Department recommend award to Simmons Gun Specialties for twelve Bushmaster Patrol Rifles, Magazine Holders, and Tactical Slings.

Total cost of the contract is \$9,851.64 to be paid out of Department 2901 – Sheriff Operations, LE Sales Tax, Account Number 91300 – Machinery/Equipment. The budgeted amount for this purchase is \$9,600.00. The Sheriff's Department has savings in account 91300 which will cover the additional expense.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

D. First Reading 66-10AUG06 Jemerson Creek Road

Ms. Turner reported the bid for Jemerson Creek Road Low Water Crossing Project closed on August 10, 2006. Six bids were received. Purchasing and the Public Work's department recommend award C.L. Richardson Construction Co., Inc. for submitting the low bid.

Total cost of contract is \$57,266.20 with a 10% contingency of \$5,726.62 for a total Purchase Order amount of \$62,992.82. This contract will be paid out of department 2045 Public Works Design and Construction, account number 71100 – Outside Services. The original budget was \$35,000.00. Please see the attached memo from Shane Creech regarding the amount over budget.

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

2. Treasurer – First Reading Boone County Purchasing Card Policy

Kay Murray, Treasurer and June Pitchford, Auditor were present on behalf of this item.

Ms. Pitchford began by giving a brief history of how the Purchasing Card came to be. She explained the process originated in our purchasing department and was a culmination between the purchasing department, the auditors department and the treasurers department.

Ms. Murray continued by explaining with the new process, our departments should find it easier to order items from local vendors and through the internet. This will allow us to obtain the best possible pricing. She continued by stating when all departments are using

the P-Card, we should be able to eliminate the smaller "store accounts".

Commissioner Schnarre stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

3. Budget Amendment to transfer from GF to Cap Project

June Pitchford, Auditor's office was present on behalf of this item

Ms. Pitchford explained this budget amendment was to transfer money in the general fund, which are designed for capital projects, to the appropriate capital project fund
