A. Second Reading 76-02NOV06 – Mechanic Services Heavy Equipment

Commissioner Miller moved now on this day the County Commission of the County of Boone does hereby award bid 76-02NOV06 Mechanic Services – Heavy Equipment & Trucks Term and Supply to the following vendors:

- Truck Repair Services Award to the low bidder, Al Scheppers Motor Co.
- Heavy Equipment Repair Services Award contracts to **both Crown Power and Equipment and Tri-State Construction Equipment.** The Public Works will determine who receives the repair work based on the proximity of the equipment.
