The meeting was called to order at 1:30 p.m.

1. Purchasing

Melinda Bobbitt, Director of Purchasing was present on behalf of these items.

A. Amendment to Contract 52-27JUN06 - Hail Damaged Commercial Buildings

Ms. Bobbitt stated Attached is an amendment adding additional buildings to contract number 52-27JUN06 – Hail Damaged Commercial Buildings for repair work by Watkins's Roofing for hail damage occurred in 2006. This amendment adds the Reality House, South Facility and Fairgrounds facilities to our contract. Watkins's Roofing confirmed that their bid price is still good from bid 52-27JUN06 – Hail Damaged Commercial Buildings.

Invoices will be paid from department 6200 – Capital Repairs and Replacements, account 60100 – Building Repairs/Maintenance. A total of \$68,800 is being added for these building repairs to this contract. Repair work on buildings is as follows:

Reality House: \$18,050.00 South Facility: \$8,800.00 Health Facility: \$41,950.00

B. 02-06MAR07 Tires

Ms. Bobbitt stated the bid for Tires: Passenger Vehicles, Patrol Vehicles and Light Duty Trucks closed on March 6, 2007. Three bids were received. The evaluation committee reviewed the bids on March 12. The evaluation committee consisted of Greg Edington / Public Works, Dave

Forward / Planning and Building Department, Leasa Quick / Sheriff Department, and Captain Greg Vendergriffe / Sheriff Department.

The evaluation team discussed what was the most economical award for the County and yet an award that would not be too cumbersome for departments to handle contract administration. It was decided that a line item award would be too difficult to administer. The evaluation team's award reasoning per line is attached. For ease of contract administration, recommendation for award is as an "all or none" award per section as follows:

Passenger Vehicle Tires – Big O Tires
Pickup Truck/SUV/Van Tires / Aggressive Tread Pattern – Cross–Midwest Tire
Pursuit Tires – Primary Supplier: Firestone / Secondary Supplier: Cross-Midwest
