Boone County Mental Health Board

The Mental Health Board met on Feb 27 to discuss pursuing a tax for mental health. They discussed the Mil tax and the local sales tax as options and voted to pursue the mil tax. They also discussed the need to develop an action plan and present their plan to the County Commission.

Columbia/Boone County Board of Health

The Board of Health met on March 8. Safe Kids Day will be April 28. The Health Director discussed emergency preparedness training at schools. The enforcement of the Columbia smoking ordinance was discussed. There we 57 reported violations. Animal control and licensing: the subcommittee is gathering data for the data base. Dental Health: There is a real shortage of dentists who are willing to take Medicaid patients because of the low level of reimbursement for services.
