4. Purchasing

A. Parking Lot Surface Improvements 25-19APR07(First Reading)

Ms. Bobbitt reported the bid for Parking Lots Surface Improvements closed on April 19, 2007. Five bids were received. Both the Public Works South Facility parking lot and the Reality House parking lot were included in the bid specifications, however, the total price for both lots came to \$20,041.45. The budgeted amount for these projects was \$12,000.00 total. Therefore, Purchasing and the Facilities Maintenance Department recommend awarding only the South Facility lot improvements to APAC Missouri, Inc. for a total of \$12,155.50. The additional \$155.50 will come out of money remaining in the Class 6 Facilities Maintenance budget.

This contract will be paid out of Department 6100-Facilities and Grounds Maintenance, Account 60100-Building Repairs/Maintenance.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

B. Cooperative Contract for Change Management System (First/Second)

It is further ordered the Presiding Commissioner is authorized to sign said contract.
