Gary German, Boone County Sheriff's Department, was present on behalf of this item.

Mr. German stated the Sheriff's Department had a Glock 18 pistol that was not a weapon that was usable everyday. Mr. German also stated the Sheriff's Department has a single launcher gas gun and they would like to purchase a new gas gun that can fire two rounds. The new gun costs \$2,100 with a trade-in value on the old gun being \$1,280, leaving a balance of \$820. Mr. German stated they would like to cover the remaining balance with funds from the Justice Assistance Grant, account 91300.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available meeting with an appropriate order for approval.

2. Mid-Missouri Internet Crimes Task Force

Mike Lederle, Mid-Missouri Internet Crimes Task Force, was present on behalf of this item.

Mr. Lederle stated this was a continuation of a previous grant approved in 2006. Mr. Lederle stated they have been approved for a total project cost of \$191,482.05. He stated this grant allows the Task Force to continue working on the project.
