Dwayne Carey, Sheriff, stated that his department is also receiving cuts in this grant award. He stated that since the amount his department receives is becoming less and less each year, he wanted to advise the commission that he might consider not taking the grant in future years, as it will become more costly to apply for the grant and keep up with the requirements than the grant award would cover. Mr. Carey stated no services would be cut as a result of this action.
