1. Shared GIS Consortium Agreement Amendment (first reading)

Mr. Warzinik stated this is a continuation of the agreement with Boone Electric Cooperative and the City of Columbia. The original agreement was a cost-share for data conversion. In 2000, there was an amendment to purchase a server. In 2003, there was another amendment to outline the ownership of the files that were converted. This amendment puts terms of use on the data. It allows the custodian of the data to put the data into 3 different categories of usage.

2. 93-18DEC07 – Emergency HVAC Services Term and Supply (first reading)
