The meeting was called to order at 9:30 a.m.

Purchasing

Melinda Bobbitt, Director of Purchasing, was present on behalf of these items.

1. Bid Opening: 15-03APR08 – Minor Hill Road Bank Stabilization

2. Cooperative Contract – G031407 - Photocopiers (first reading)

Ms. Bobbitt stated Purchasing requests permission to utilize the University of Missouri cooperative contract for Photocopiers and maintenance with Ikon Office Solutions of Columbia, Missouri. This is a county-wide Term and Supply contract, and the initial term is through December 31, 2008 with two one-year renewals.

Included is a Purchase Requisition for a photocopier purchase for the County Clerk's office. Total cost of photocopier is \$16,276.00 and will be paid from Departments 1132 – Election & Registration, and 2300 – Election Services, Account 92300 – Replacement Machinery and Equipment.

\$13,100 was budgeted in Department 1132, Account 92300 and \$3,200 was budgeted in Department 2300, Account 92300 for a total budget of \$16,300.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

3. 12-20MAR08 – Parking Lots Surface Improvements and Change Order #1 (first read on 3/20/08)

Ms. Bobbitt stated the bid for Parking Lots Surface Improvements closed on March 20, 2008. Six bids were received. Purchasing and the Facilities Maintenance Department recommend award to Frech Paving Company for offering the lowest and best bid for Boone County.

Total cost of contract is \$17,112.06 with a 10% contingency amount of \$1,711.21 for a Purchase Order total of \$18,823.27. Contract will be paid from Department 6100 – Facilities and Grounds Maintenance, Account 60100 – Building Repairs and Maintenance. The budgeted amount was \$20,000.

Included is a change order to this contract to clean three holes of dirt, loose debris, apply tack oil, and patch with hot mix asphalt at the Juvenile Justice Center. Change Order adds \$400.00 for this work.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby award bid 12-20MAR08 – Parking Lots Surface Improvements to Frech Paving Company, and approves Change Order #1 in the amount of \$400. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract and change order.

Walnut and direct the County Auditor to amend the budget and establish the necessary appropriations accordingly. The remodeled offices will house the operations of the Prosecuting Attorney Child Support Enforcement Unit. The costs of construction will be paid from residual unrestricted cash remaining in capital project Fund 400 and Fund 404 and the County Commission does hereby authorize the transfer and use of said residual unrestricted cash for this project. To the extent that interest is earned and collected and is added to the available cash in the construction fund, the County Commission does hereby authorize the appropriation of said interest for this remodel project and authorize the County Auditor to amend the project budget accordingly.

Commissioner Elkin seconded the motion.
