2. 26-22APR08 – Ready Mix Concrete/Cement Term and Supply (first reading)

Mr. Boldan stated the bid for Ready Mix Concrete/Cement Term and Supply closed on April 22, 2008. Two bids were received. Purchasing and the Public Works Department recommend award to Central Concrete Company as the primary supplier for offering the lowest and best bid, and Columbia Ready Mix as the secondary supplier.

The Term and Supply contracts will be paid from Department 2040 – PW Maintenance Operations, Account 26000 – Pavement Repairs Material. \$130,000 was budgeted for 2008.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

3. 18-15APR08 – Street Name Signs Term and Supply (first read on 5/1/08)

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby award bid 18-15APR08 – Street Name Signs Term and Supply to Hall Signs, Inc. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.

4. 21-15APR08 – Newspaper Advertising Term and Supply (first read on 5/1/08)

Court Administrator

Kathy Lloyd, Court Administrator, was present on behalf of this item.

5. BJA Grant Application for CIT Implementation

Ms. Lloyd stated the Crisis Intervention Teams (CIT) Implementation is a project that has been done in cooperation with law enforcement agencies. CIT is an approach to coordinate and train law enforcement officers who encounter mental health crises in their jobs on the street to be better equipped on how to intervene in those circumstances; and to develop protocol on what to do in response to those cases. This application is for expenses in the amount of \$145,165. There is a 20% match which will be provided by the Columbia Police Department. The remaining match will be provided by the Sheriff's Department. The other expenses include 1040 hours each year for a program assistant, and for sending the CIT team to a Bureau of Justice Assistance meeting on two occasions.

Commissioner Elkin asked if the team would consist of representatives from all the different agencies.

Ms. Lloyd stated that is the intent.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby authorize the Commissioner Karen Miller to sign the BJA Grant application and letter of support.

6. Request to Transfer Above Authorized Transfer Salary (ATS)

Mr. Mink stated he is requesting an annual salary increase for John Watkins retroactively effective to January 1, 2008. Mr. Watkins was previously classified as Project Manager at grade 45. As a result of reorganization, Mr. Watkins' position was reclassified to Infrastructure Manager as of January 1, 2008. The recommendation regarding salary grade was not available at the time, so the salary was left unchanged. That analysis has been completed and the recommendation is to set the grade at 47.

hereby approve the transfer of John Watkins to position no. 615 – Infrastructure Manager, at 113.7% of Mid-Point.

Commissioner Elkin stated he was contacted by a land owner from northern Boone County a couple of months ago who informed him of a water reservoir easement on his property. This easement was established in the 1930s, when they would designate ponds on people's land as able to be used by the public for water in the case of a declared emergency drought. This easement will relinquish the use of the pond back to the land owner.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the attached quit-claim deed for a water reservoir easement.

Commissioner Miller reported on the following:

Courthouse Expansion Project: Commissioner Miller stated the fourth floor stud walls and windows have been installed creating a work space for wall and ceiling finishes. The roof is finishing up with placement of metal standing seam on the sloped surfaces. Other major items finished include fourth floor fireproofing on all steel, and completion of half the third to fourth floor exterior walls. The weather is slowing the project down some, but the masons are setting the limestone on the side of the building. The contingency hasn't changed; it is still \$568,000.
