Purchasing

Melinda Bobbitt, Director of Purchasing, was present on behalf of these items.

1. Bid Opening: 29-05JUN08 – Waterfront Drive North Overlay & Drainage Improvement Project

2. Sole Source Purchase – CML 911 Command Post (first reading)

Jim McNabb requests permission to utilize CenturyTel as a sole source provider for the purchase of two Sentinel CML 911 Command Posts located in the Joint Communications Department. Purchase is for two each at \$18,110.00 for a total of \$36,220.00 and will be paid out of Department 2020 – E-911 Emergency Telephone, Account 91301 – Computer Hardware. Maintenance is included in the first year and will be approximately \$2,300/year in future years.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

3. 28-15MAY08 – Westwood Meadows Subdivision Asphalt Overlay & Roadway Drainage (first read on 5/15/08)

Ms. Bobbitt stated the bid for the Westwood Meadows Subdivision Asphalt Overlay & Roadway Drainage closed on May 15, 2008. Five bids were received. Purchasing and Public Works recommend award to C.L. Richardson Construction Company, Inc. for offering the lowest and best bid for Boone County.

Contract award is for the Base Bid for \$102,266.75 and the Alternate Bids for \$4,022.10 for a total contract award of \$106,288.85. The Purchase Order includes a 10% contingency of \$10,628.88 for a Purchase Order total of \$116,917.73. Contract will be paid from Department 2040 – PW – Maintenance Operations, Account 71100 – Outside Services. The budgeted amount was \$228,135.00.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby award bid 28-15MAY08 – Westwood Meadows Subdivision Asphalt Overlay & Roadway Drainage to C.L. Richardson Construction Company, Inc. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.

4. MM54 – Sodium Chloride Term & Supply (first reading)

Ms. Bobbitt stated the bid for Sodium Chloride Term & Supply closed on May 20, 2008. Three bids were received. Purchasing and Public Works recommend award by low bid to North American Salt Company.

This term & supply contract will be paid out of Department 2040 – PW Maintenance Operations, Account 26300 – Material and Chemical Supplies. The 2008 budget is \$180,000 and \$143,310 remains in the account at this time.

5. Amendment Number One – 85-11DEC07 – Crushed Stone Aggregate & Chip Seal Products (first and second reading)

Commissioner Pearson stated the original agreement for delivery pricing only included fuel pricing through \$4.50 per gallon. This amendment would extend the pricing through \$6.00 per gallon. At the time of the agreement, it wasn't anticipated that fuel prices would rise so high.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby approve Amendment Number One to 85-11DEC07 – Crushed Stone Aggregate & Chip Seal Products. It is further ordered the Presiding Commissioner is hereby authorized to sign said amendment.
