3. Public Comment

Dave Griggs and Dave Meyer, R.E.D.I.

Mr. Griggs stated he would like to present a proposal to the County Commission to amend the current Chapter 100 policy. The proposed amendment would read as follows:

"In the event of a public or private utility provider making a minimum capital infrastructure investment of Eighty Million Dollars (\$80,000,000.00) in the county of Boone the Chapter 100 Abatement or "Grant Payment" amount shall be negotiated by the County Commission in consultation with R.E.D.I. and the impacted taxing entities."

R.E.D.I. has been contacted by a utility provider who is considering making an infrastructure investment of over \$100 million in either Boone County or Audrain County. Either site would be in the Centralia School District. R.E.D.I. is working with the school district and the other entities involved to provide some kind of equitable proposal that is beneficial to both counties. To do this, it will take a considerable abatement.
