Mr. Boldan stated the bid for Replacement & Installation of Ford Power Stroke Diesel Motor closed on July 18, 2008. Three bids were received. Purchasing and the Public Works Department recommend award to Joe Machens for offering the best bid for Boone County of \$11,974.57. A

\$300.00 rebate will follow from Ford following purchase of motor for a total cost of \$11,674.57 for the motor.

Contract is \$11,974.57 and will be paid from Department 2040 – Public Works – Maintenance Operations, Account 92400 – Equipment Repairs/Maintenance.

## 5. 33-10JUL08 – Lloyd Hudson Low Water Crossing Project (first reading)

Mr. Boldan stated the bid for Lloyd Hudson Low Water Crossing Project closed on July 10, 2008. Six bids were received. Purchasing and the Public Works Department recommend award to Streck Construction Company for offering the lowest and best bid for Boone County.

Total cost of contract is \$64,079.02 with a 10% contingency amount of \$6,407.90, for a Purchase Order total of \$70,486.92. The contract will be paid from Department 2045 – PW Design and Construction, Account 71100 – Outside Services. The budgeted amount was \$51,666.00.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

## 6. 32-10JUL08 – Chip and Seal Project (first read on 7/10/08)

Mr. Boldan stated the bid for Chip and Seal Projects closed on July 10, 2008. Of the two bids received, Purchasing and the Public Works Department recommend award to Missouri Petroleum Products Company for offering the lowest and best bid for Boone County.

Recommendation for award is the Base Bid for \$666,860,38, Construction Add On option for \$151,310.00, and Alternate #2 for the change of rock option at no additional cost. Total contract is for \$818,170.38. The 10% contingency amount is \$81,817.03 for a Purchase Order total of \$899,987.41. The contract will be paid from Department 2040 – PW Maintenance Operations, Account 71100 – Outside Services. The budgeted amount was \$545,330.00.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby award bid 32-10JUL08 – Chip and Seal Projects to Missouri Petroleum Products Company. It is further ordered the Presiding Commissioner is hereby authorized to sign said contract.
