Information Technology

Ryan Irish, Information Technology, was present on behalf of these items.

1. Budget Revision for DSL Line Charges (first reading)

Mr. Irish stated the Sheriff's Department and Prosecuting Attorney's Office have a separate DSL line that allows them to do research that the main DSL line prohibits with security features.

Commissioner Elkin stated the memo attached to the budget revision states that the department was short funds, and they need this revision to pay the \$40 line charge for December.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

2. Buy-out of Computer Equipment (first reading)

Mr. Irish stated we had a lease with HP for a PC that has run out, and instead of renewing the lease, we are just going to buy the PC outright. The cost of the buy-out is \$163.00.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

Purchasing

Tyson Boldan, Purchasing, was present on behalf of these items.

3. 68-03DEC08 – Solid Block Asphalt Sealant Term & Supply (first reading)

Mr. Boldan stated the bid for Solid Block Asphalt Sealant Term & Supply closed on December 11, 2008. Three bids were received. Purchasing and the Public Works Department recommend

awarding Paving Maintenance Supply, Inc. as the primary supplier for the listed block sealant for having the lowest and best bid. The Public Works Department also recommends award to Vance Brothers, Inc. for the alternate block sealant for reason stated in the attached memo.

This is a term and supply contract and invoices will be paid from Department 2040 – PW-Maintenance Operations, Account 26000 – Pavement Repairs Material. \$400,000.00 is budgeted for this service.

Commissioner Pearson stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

4. 70-30DEC08 – Vehicle Preventative Maintenance Term & Supply (first reading)

Mr. Boldan stated the bid for Vehicle Preventative Maintenance Term & Supply closed on December 30, 2008. Only one bid was received. Purchasing and the Public Works Department recommend award to MFA Petroleum Company for offering the lowest and best bid for Boone County.

This is a term and supply contract and invoices will be paid from Departments 1251 – Sheriff Department, 1255 – Corrections, Account 59100 – Vehicle Repairs. \$40,300.00 is budgeted for this service.

5. 49-27OCT08 – Financial and Compliance Auditing Services (first read on 1/27/09)
