Mr. Dillingham stated there is a prepayment period for those who wanted to pay in cash and did not want to have an annual assessment applied to their property. This was the step to net out the amount that does need to be financed over time. The W.B. Smith portion is small only representing about \$27,000.00 of the \$204,000.00. Only two residents wanted to pay over time. Hill Creek NID was a little bit more of an unusual situation. There were costs associated with this NID that DNR would not cover. The County helped to provide the financing for this project. The prepayments coming in helped to allow for the County to move on and determine the bond sizing.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby authorize and direct the issuance, sale and delivery of \$204,000.00 principal amount of general obligation bonds, series 2010A, of Boone County, Missouri; prescribing the form and details of said bonds; providing for the levy and collection of an annual tax for the purpose of paying the principal of and interest on said bonds as they become due; and authorizing certain other documents and actions in connection therewith.
