Treasurer's Office

Toni Stegman, Jack Dillingham, and Lisa Rolland were present on behalf of this item.

2. Authorize General Obligation Bonds for paying costs of the Lakeview Estates, Lakewood Villas, and Valley Creek Neighborhood Improvement District Project (first and second reading)

Ms. Rolland stated the certified costs were completed and assessed on March 3. The County then went into the pay off period which ended April 4th. There were 31 payoffs and that is roughly 26 % paid off which leaves 89 people that need to be bonded for. Here today we are

present to request for authorization to bond. Toni Stegman with Gilmore and Bell and Jack Dillingham with Piper Jaffrey are present for further explanations.

Commissioner Miller stated so the people that prepaid have paid part of that premium.

Mr. Dillingham stated yes, it was from the certified costs.

Ms. Roland stated all except there is \$900.00 in the bond that is interest on the bond.

Commissioner Miller stated she just wanted to make sure that the people who prepaid were charged also.

Mr. Dillingham stated the interest can be seen on page 5 that if you are looking at what is an aggregate cost the County does have the ability to setoff the interest and prepay the bond after 2 years old.

Commissioner Miller asked what is done with the money that people keep paying early for their share of the debt.

Mr. Dillingham stated the funds are just going to stay in the debt service fund. Even if you don't have enough money to redeem them all you may want to redeem what you can here as opposed to keep paying 3 and a half percent.

Ms. Stegman stated we are present today to request Commission approval for the bonds. These are a standard orders similar to the bond orders the Commission has approved in the past.

Commissioner Miller on this day the County Commission of the County of Boone does hereby authorize and direct the issuance, sale and delivery of General Obligation Bonds, Series 2011A, of Boone County, Missouri; Prescribing the form and details of said bonds; Providing for the levy and collection of an annual tax for the purpose of paying the principal of and interest on said bonds as they become due; And authorizing certain other documents and actions in connection therewith.
