Sheriff's Department

1. Violence Against Women Act grant application (first and second reading)

Captain Chad Martin and Investigator Heath Chinn were present on behalf of this item. Captain Martin stated the Sheriff's Department is requesting Commission approval to apply for the State of Missouri Domestic Violence Grant – Violence Against Women Act. Captain Martin stated this is the same grant the department has been applying for, for several years. Captain Martin stated there were very minor, if any changes this year. Captain Martin stated the only change is that it is now a two year program. Captain Martin stated Commissioner Robb needed to sign an assurances page.

2. MoDOT Work Zone Traffic Enforcement (first reading)

Captain Martin stated he thinks their target is the Highway 63 construction by the airport. Captain Martin stated the first part of the agreement takes the County through the end of the year, but grants the Sheriff the ability to renew it.

Commissioner Miller asked if MoDOT was paying the County to do this.

Captain Martin stated they are. Captain Martin stated they are paying the County \$1,000 for the first period, but will keep giving us money as long as we continue to help them.

Commissioner Elkin asked if this would be a coordinated effort with the State and the City.

Captain Martin stated he was unsure about the City, but it would be coordinated with the Highway Patrol. Captain Martin stated we have done this in the past but it was called something different.

Commissioner Robb stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with an appropriate order for approval.

7. Violence Against Women Act grant application (first and second reading)

Mr. Cover stated this is a two year grant that runs from 2012 to 2013. Mr. Cover stated the Circuit Court has been receiving funds in some parts since 2009. Mr. Cover stated this grant application is requesting a total project cost of about \$350,000. Mr. Cover stated there is a 25% local match, but it will mostly be made up by the defendants who are ordered to attend. Mr. Cover stated this funds the MEND program, which is a batterer's intervention program, as well as his salary.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the grant application by the Boone County Circuit Court for the STOP Violence Against Women Grant. It is further ordered the Presiding Commissioner is hereby authorized to sign said application.

Ms. Adkins stated the funds support two prosecuting attorneys, a victims specialist, part of the salary of the prosecutors, and the full benefits of the specialist. Ms. Adkins stated they were requesting \$246,438.30, and the local match is \$87,047.54.

Commissioner Miller moved on this day the County Commission of the County of Boone does hereby approve the grant application by the Boone County Prosecuting Attorney for the STOP Violence Against Women Grant. It is further ordered the Presiding Commissioner is hereby authorized to sign said application.
