1. Geography Awareness Week Proclamation Request (first reading)

GIS Manager Jason Warzinik was present on behalf of this item. Mr. Warzinik stated the proclamation request has come through the Missouri Geographic Alliance. Mr. Warzinik stated this year's Geographic Awareness Week theme is "adventure in your own community." Mr. Warzinik stated since GIS and geography are used throughout County and City governments, they are trying to get as many entities as possible to sign the proclamation. Mr. Warzinik stated Geographic Awareness Week was started in 1987 when President Ronald Reagan signed the proclamation at the federal level. Mr. Warzinik stated nothing has been done in Boone County thus far, but this year they are teaming up with other GIS consortium entities and the University of Missouri to put on an event Wednesday at City Hall.

Commissioner Elkin asked if the proclamation is sent to Shannon White, or if the County will keep it.

Mr. Warzinik stated there are two copies, one to keep and one to send back to her.

Commissioner Atwill stated to have a Geographic Awareness Week; we are going to be more aware of our Geography?

Mr. Warzinik stated it will hopefully create an awareness of how geography plays a role in our daily lives.

Commissioner Elkin asked if there is a deadline for this.

Mr. Warzinik stated the only deadline is that Geographic Awareness Week is coming up

in two weeks.
