# 2. Utility Relocation agreement with Union Electric Company d/b/a Ameren Missouri (first reading)

Mr. Shawver stated this is a gas line. Mr. Shawver stated Ameren is prepared to do the work, and the contracts have been reviewed by legal counsel.

Commissioner Miller stated they were there before the County road was. Commissioner Miller stated basically, whoever was there first doesn't have to pay. Commissioner Miller stated if the County had an easement, and they were in our easement, they would pay to relocate the line.

Mr. Shawver stated this is a part of making the road four lanes.
