The meeting was called to order at 9:30 a.m.

Juvenile Office

1. Juvenile Court Diversion grant renewal (first and second reading)

Rick Gaines from the Juvenile Office was present on behalf of this item. Mr. Gaines stated we've had this grant since 1996. Mr. Gaines stated the proposal is that we will receive a total of \$87,433, which will fund two projects. Mr. Gaines stated one project will be the probation enhancement program which employees two, full time juvenile officers. Mr. Gaines stated they work with intensive probationary services as well as kids who have mental health and abuse problems. Mr. Gaines stated the other program is the intensive intervention model program which employs a part time family therapist at 20 hours per week. Mr. Gaines stated that person works with our intensive kids and families to do family therapy in the home. Mr. Gaines stated it's fully reimbursable by youth services. Mr. Gaines stated we're asking the County to approve the grant for the \$87,433.

Commissioner Miller stated the numbers don't jive, the intervention program is \$15,000 and the probation services enhancement is \$82,000, so that would be \$97,000.

Mr. Gaines stated we ask for those amounts, but they've always given us the same amount. Mr. Gaines stated the \$15,000 is to pay for a full year for our family therapist, and we only receive partial funding for it. Mr. Gaines stated for the past five years, we've always gotten the \$87,433. Mr. Gaines stated we ask for it, but they never fund the total request. Mr. Gaines stated once we run out of grant funds, we turn to our budget to fund the therapist.

Commissioner Miller confirmed it's already included in his budget.

Mr. Gaines stated yes. Mr. Gaines stated it's one contract now, it's no longer spread between two contracts like it used to be.

Commissioner Miller moved on this day the County Commission of the County of Boone

does hereby accept the following Juvenile Court Diversion grants from the State of Missouri, Department of Social Services: the Intensive Intervention Model program, and the Probation Services Enhancement in the amount of \$87,433.
