# 1. Cooperative Contract: 101/2012 – Radios and Radio Related Installation and Repair (first reading)

Director of Purchasing Melinda Bobbitt was present on behalf of this item. Ms. Bobbitt read the following memo:

The Boone County Sheriff Department requests permission to utilize the City of Columbia cooperative contract 101/2012 – Radios and Radio Related Installation and Repair.

This is a Term and Supply contract and invoices will be paid from department 2901 – Sheriff Operations LE Sales Tax and 1251 – Sheriff, account 60200 – Equipment Repairs/Maintenance and 60250 – Equipment Installation Charges.

Commissioner Miller stated it would be the same accounts in Public Works.

Commissioner Atwill asked if this is a term and supply contract.

Ms. Bobbitt stated it is. Ms. Bobbitt stated Wireless USA is in Columbia.
