2. First reading; Sole Source Renewals for 2013

Melinda Bobbitt read the following memo:

Purchasing has received requests from departments to renew on-going sole source approvals. We are requesting approval to renew the attached list of sole source vendors for another year, ending on December 31, 2013. The 2013 list of vendors was advertised in the Columbia Missourian and the Columbia Tribune on December 5, 2012.

After reading the memo, Ms Bobbitt stated that this is done annually .There were no further questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Resource Management

3. First reading; Proposed fee increases for Dept. 1710 (Planning & Zoning) and Dept. 1720 (Building Codes)

Stan Shawver spoke to this item stating that this is part of the budget process. A review has been done looking at the history of past fees and how they arrived at the proposed fee increases.

Mr. Shawver said they were asked to hold off for several weeks and then bring back which they are now doing. Commissioner Elkin stated that this process was based on using the Gross Area Modifier and choosing the most conservative formula to make the adjustments. Mr. Shawver agreed. There were no further questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Mr. Shawver addressed an issue that took place at the last Commissioners Meeting on December 4, 2012 concerning the fees for the Wastewater On-site Sewage. The Commission Order did not address the effective date of these fees and felt that this was not the intent of the

Commission. The effective date is January 1, 2013. Commissioner Atwill stated that it was not the intent of the Commission and that the original order should be rescinded and do it properly with a new Order with the effective date of January 1, 2013. Mr. Shawver and Commission Elkin agreed.

A new Commission Order will be prepared by the Deputy County Clerk with the effective date of January 1, 2013 for Commissioners signatures at the next meeting, December 11, 2012.

4. First reading; Cooperative Agreement – Boone County & City of Ashland – Road & Bridge Improvement/Repair

Mr. Shawver stated the agreement is straight forward. Commissioners agreed. Commissioner Elkin asked if this is for core testing. Mr. Shawver said yes. There were no further questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.

Information Technology

5. 1st and 2nd reading; Emergency replacement of laser printer in the County Counselor's Office.

Aron Gish spoke to this item and stated that this is an emergency replacement of a laser printer that failed. The printer was manufactured in 1994 and is currently in the County Counselor's Office. This is an asset which is tracked and monitored.

Commissioner Elkin moved on this day the County Commission of the County of Boone does hereby approve the request for use of "Unanticipated Hardware Emergencies" account 1170-92301 to purchase a replacement laser printer at the cost of \$480.77. This price includes 1 laser printer with 3 years manufacturer's warranty and shipping.

6. 1st and 2nd reading; Add one new wireless network access point to the Sheriff's Department Annex basement level

Aron Gish stated that the Annex was constructed with wireless access on the main level. As the use of the building increased, wireless access was needed in the basement level.
