The meeting was called to order at 1:30 p.m.

Purchasing

1. First reading; Duplicating Services Term & Supply

Melinda Bobbitt read the following memo:

Attached is the bid tabulation for the two responses received for the above referenced bid. Please review the recommendation below and let me know if you have any questions or concerns. Two bid responses were received for this bid, one from Brake Printing and the other from Office Depot. Brake Printing holds the current contract for Duplicating Services which expires June 30, 2013. They submitted pricing identical to our current prices.

The pricing submitted by Office Depot are those already available to us through The Cooperative Purchasing Network ("TCPN") contract #R5023 which has been in place at the County since March, 2011. This contract was put in place as an alternative Office Supplies contract, however it also includes their Custom Printing Services. Although

Office Depot's price list doesn't include all of the categories requested in our bid, their bid offers competitively priced options for many of the categories.

The Purchasing Department recommends award to Brake Printing for submitting the only bid for all items requested.

The department also recommends Office Depot's Custom Printing Services (available via Boone County Contract #R5023) as an optional vendor for printing services.

There were no comments or questions.

Resource Management

4. First reading; Acceptance of Security Agreement and Letter of Credit for Rocky Fork Wastewater Treatment Plant and Collection System

Nicki Fuemmeler said that Resource Management is requesting acceptance of the Security Agreement and Letter of Credit for Rocky Fork Wastewater Treatment facility and also on the Collection System. The amount for the Treatment facility is \$117,300 and for the Collection System it is \$190,362.

Sheriff's Department

5. First reading; Memorandum of Understanding with Youth Community Coalition

Captain German said that the Youth Community Coalition has contacted the Sheriff's Department to seek the continuance of funding for youth compliance checks. This is mostly aimed at businesses that sell to underage purchasers.

Captain German also said that the department has purchased most of the technical equipment needed but funding will eventually run out and the department will be strapped to continue these checks with the decreasing funding from the Liquor Control. We have received \$5,000 this year to do about 30 compliance checks.

Commissioner Atwill asked if this was a grant.

Captain German said that the Youth Community Coalition applied for the grant and then dispersed the funds out. The Sheriff's Department did not apply for the grant. They said they would like to give the department the money in exchange for doing the compliance checks and report back to them with the results. We will do an operation which would be anywhere from 5-10 compliance checks. These operations will be interspersed throughout the year until completed.

Commissioner Thompson asked about compliance checks if there was no grant money.

Captain German said the department has been fortunate in that Highway Safety has

provided money which pays for salaries and also used to purchase surveillance equipment.

There were no further comments or questions.

Commissioner Atwill stated this is a first reading and requested the Deputy County Clerk to schedule this item for a second reading at the next available commission meeting with appropriate order for approval.
