1. First reading; Bid Opening 34-22AUG13 – BCPW South Facility Lot Grading & Access Drives

The following bids were received:

2. First reading; Bid Award 32-30JUL13 – Pre-printed Envelopes for Boone County Collector.

Amy Robbins read the following memo:

The Request for Bid for 32-30JUL13 – Pre-printed Envelopes closed on July 30, 2013. Ten bid responses were received. Bear Graphics and Printing of Centralia, MO was the low bidder this year as they were last year. In working with Bear Graphics during the 2012-2013 contract period, however, the Collector's Office experienced difficulty in obtaining test samples, long wait times to receive envelope proofs after the order was made and envelope shortages upon delivery. Due to these issues, the Collector's Office recommends award to the 2nd low bidder, Affordable Printing Solutions of Holts Summit, MO for offering the best bid for Boone County.

Cost of the contract is \$9,399.33 and will be paid from department 1150 – Collector, account 23001 – Envelope and Office Forms Printing. \$10,330.00 was budgeted for this bid.

Commissioner Miller asked what the difference in the bids were.

Ms. Robbins said that Bear Graphics bid was \$8,838.23 and the bid from Affordable Printing Solutions was \$9,399.33.

There were no further comments or questions.

3. First reading; Bid Award 31-12JUL13 – 2013 Roadway Surface Seal Treatment Project

The Request for Proposal for 31-12JUL13 – 2013 Roadway Surface Seal Treatment Project closed on July 13, 2013. Four proposal responses were received.

The evaluation committee recommends award as follows per their attached Evaluation Report:

9. Second reading; Elimination of the 911 Telephone Tax. (1st reading 8-20-13)

Commissioner Atwill made the following motion:

WHEREAS, on November 5, 1985, the voters of Boone County approved a telephone tax on landline telephones to fund a 911 Public Safety Answering Service; and

WHEREAS, the County Commission has for many years routinely set a tax levy at the 2% of the tariff rate as contemplated by RSMo §190.310; and

WHEREAS, the proceeds of said tax are accounted for in Boone County Fund #202, the E-911 Emergency Telephone Fund; and

WHEREAS, the decline in the use of landline telephone service, coupled with the increase in the use of cellular phones, has had reduced the effectiveness of this landline tax; and WHEREAS, on April 2, 2013, the voters of Boone County approved a sales tax to fund a new 911 / Joint Communications Service to be operated as a department of Boone County government; and

WHEREAS, the sales tax levy from the April 2, 2013, ballot issue will take effect on October 1, 2013, with collections of the sales tax to follow in late 2013; and

WHEREAS, the County Commission indicated that if the voters approved the April, 2013 sales tax proposal, that it would eliminate the landline telephone tax; and

WHEREAS, the County Commission intends by this Commission Order to keep the promise made to the citizens of Boone County.

NOW, THEREFORE, on this day the County Commission of the County of Boone does hereby set the E-911 tax levy at 0% effective January 1, 2014 (reduced from 2% of the tariff rate), and by these presents eliminates this tax levy as of January 1, 2014. As contemplated by RSMo §190.310.3, the County Clerk is requested to publish in the minutes of the County Commission the elimination of this levy and, in coordination with the County Treasurer, is further requested to notify by mail every service supplier (any provider of exchange telephone services) registered with the County.
