## 2. First reading; 2014-2015 STOP-VAWA grant application

Kathy Lloyd said they would like to renew this grant which is on the Domestic Assault Docket and for MEND. This was started in 2009 and the last grant was for two years and is ending this year. This is a two year renewal and we are asking for the same funds, but a little more for MEND here in Boone County.

Commissioner Miller asked what MEND is about.

Ms. Lloyd said MEND is Men Exploring Non-violent Directions. It is a batters' intervention program that the Family Counseling Center offers. It is a \$40/week program for 27 weeks and the grant/program provides a stipend for those to attend based on income. Each participant must pay a minimum of \$10/week. About 78% get the full stipend of \$30 and they are accountable to the court to attend upon receiving the stipend. The Domestic Assault Court Coordinator tracks the attendance and helps the court in the facilitation of compliance. There is no County match. The match comes from the co-pay that the individual pays to attend the class.

Commissioner Thompson noted on page six of the report, that of the 292 participants who graduated, only 14% had a new domestic violence case while the 150 participants who were terminated from the program, 33% had a new domestic violence case. It shows that the program does work.

The Commissioners thanked Ms. Lloyd and Ms. Loftin for all the work they do.

There were no further comments or questions.
